**AGENCY ASSISTS: 10**

1- November 15, 2016@ 19:07 hours, Officer mat Nadeau assisted the Vermont State Police with a welfare check in Huntington at Roberts's trailer park. A male was sending messages to family indicating he was going to commit suicide. The man was located and it was determined that he was having a bad day and was not going to harm himself.

2-November 16, 2016, Officer John Hamlin was contacted by Colchester Police requesting he help locate a male who had been fired from a Colchester business earlier in the day and was now making threats to coworkers that he was going to kill them for ruining his life. The man's girlfriend lives in Richmond, however he was not at her location.

3- November 19, 2016@ 18:54 hours, Officer John Hamlin responded to Lee River and Brown Trace Road in Jericho after a Trooper requested assistance after making a traffic stop. The vehicle contained four juveniles who were in possession of a case of beer and drugs. Officer Hamlin ended up searching the vehicle while the Trooper dealt with the four juveniles. He located three zip lock sandwich bags containing marijuana, multiple baggies of unlabeled pills, a pipe and a large marijuana bong. Parents were contacted and juveniles were turned over to them while VSP will be taking legal actions against at least one of the juveniles who had possession of marijuana and pills. The juvenile in possession of the drugs was recently involved in a case we investigated involving a heroin overdose here in ton.

4-November 20, 2016@ 20:22 hours, Officer John Hamlin responded to the Interstate at French Hill for a car slide off. This was one of more than twenty vehicle slide offs and accidents on the interstate due to a snow storm that the Vermont state Police were trying to deal with. John handled the call for VSP.

5- November 20, 2016@ 23:16 hours, Officer Hamlin handled another slide off on the Interstate at mile marker 81.3 (French Hill). A tow truck was requested and removed the vehicle.

6- November 21, 2016@ 02:31 hours, Officer John Hamlin responded to Route 2 in Bolton with a Trooper for a 911 hang-up call. The call was generated from the old Latham's trailer sales and was discovered to be unfounded. Seems the old phone line is acting up as now several calls had come from the same area. VSP was to notify the telephone company.

7- November 21, 2016@ 01:42 hours, Officer Hamlin was driving by the Park & Ride when he observed a vehicle on the Interstate slide off the south bound lane and into the fence behind the lot. He checked on both the operator and passenger who were fine and then waited until a tow truck arrived and pulled them back onto the road.

8- November 24, 2016, Officer Hamlin assisted the Vermont State Police with a physical family fight on Brown's Trace Road in Jericho involving an intoxicated female. Officer Hamlin was able to get statements from the victims as the female was arrested by State Police for disorderly conduct and taken to the county jail.

9- November 25, 2016@ 23:11 hours, Cpl. Brett Lindemuth assisted a Trooper with a search of a vehicle in the Town of Jericho.

10- November 28, 2016@ 20:33 hours, Officer Mat Nadeau assisted Richmond Rescue at a Riverview Commons home with an unruly patient whose doctor requested that he go to the emergency room for complications with a catheter that he had previously ripped out. This was out third encounter with this man in a week. The man became combative with rescue and Officer Nadeau who ended up having to

physically subdue him so he could be transported to the emergency room as he was now a danger to himself. Officer Nadeau then took the daughter who had power of attorney to the emergency room.

- November 15, 2016@ 21:09 hours, Officer Mat Nadeau conducted a traffic stop on Governor Peck Road. Mat was able to identify the intoxicated passenger in the vehicle who currently was under court ordered conditions not to buy, possess or consume alcohol. A breath test at the office registered a BAC of .135%. He was charged with violating his court ordered conditions and ordered into court with a citation.
- November 16, 2016@ 08:14 hours, Cpl. Brett Lindemuth started an investigation after it was learned that a student had ingested brownies he found that were cooked with marijuana and he started to feel funny and bad. The Department of Child Welfare was contacted and the case turned over to them for investigation.
- November 21, 2016@ 16:28 hours, Officer John Hamlin was sitting at the Park & Ride when a car pulled up with a medical emergency. Female exited the vehicle requesting an ambulance as her husband (age 43) that has a pacemaker was having breathing issues. John had Richmond rescue called and obtained as much information that they would need prior to their arrival. The male was transported to the emergency room.
- November 21 & 22<sup>nd</sup> the guys dealt with multiple accidents and slid offs due to the wet and sloppy road conditions.
- November 23, 2016@ 16:11 hours, Officer John Hamlin took a theft complaint. A home owner had discovered that her prescription medication had been stolen. Investigation leads us to believe that a cleaning company had been at the home and John has identified two suspects while working with the company owner. This investigation is still ongoing at this time.
- November 24, 2016, Cpl. William Bullock assisted with traffic control for the Turkey Trot and then dealt with several more vehicles sliding off the roads during the day shift.
