- **April 25, 2013@00:42 hours, Officer Joshua Hansell called to a disturbance on East Hill Road. The former girlfriend of the residence who was highly intoxicated was charged with resisting arrest, unlawful mischief & unlawful trespass. She refused a breath test and was being transported to ACT 1 when she threatened suicide so she was taken to the emergency room.**

After her exam she was taken to ACT 1 where she was refused admission and was lodged at the county jail.

- April 26, 2013 Officer Joshua Hansell called to the Mobbs home on Kenyon Road for a dispute between landlord/tenant over the noise.
- May 1, 2013@ 22:15 hours, Officer Brett Lindemuth called to a noise complaint coming from On The Rise Bakery regarding the loud music.
- May 6, 2013@ 12:46 hours, Officer Brett Lindemuth contacted about a sexual assault on a 4 year old. After taking the initial information he spoke with a detective from CUSI and based on the information received it was determined that CUSI investigators would take over this case.
- May 7, 2013@ 11:53 hours, Chief Buck took a complaint regarding a wrongful death. A town resident had passed away a few months ago and because he was transported to the emergency room law enforcement was never notified. Family members are now indicating that he was an abused elderly adult and his death was under suspicious circumstances. After obtaining formal written statements from several family members the case was reviewed by a State Police detective Lieutenant. Based on the family concerns and statements obtained with additional statements needed both in and out of state this case was transferred to a Detective Sergeant out of the Williston barracks for investigation.
- May 9, 2013@ 16:26 hours, Officer Jacob Hansell was called to a disturbance on Rogers Lane. A female, who was under federal probation conditions, was found to have a BAC of .254%. Initially she was being transported to ACT 1 when she threatened suicide. After being transported to the emergency room and being refused at ACT 1 she was lodged at the county jail. Federal Probation & Parole were notified and additional charges may be levied against her.
- May 9, 2013@ 20:13 hours, Officer Jacob Hansell was again called to the Mobbs home located on Kenyon Road for a dispute about noise from the tenant. Tenant advised being harassed by Ms. Mobbs with loud noises, banging and yelling which was disturbing the sleep of the 20 month old child. This seems to be an on/off pattern at this home with different tenants that have resided in the little studio apartment that was once a garage of the home.
- May 10, 2013@ 06:12 hours, Chief Buck again responded to the Kenyon Road home for a continuation of the above mentioned complaint. I worked it out that Ms. Mobbs would stop harassing the tenant who would be moving out of the apartment by the end of the day.
- May 12, 2013, Officer Brett Lindemuth was able to obtain information on the whereabouts of a male suspect wanted by Williston Police for grand larceny. Based on his information Williston police assisted by South Burlington police were able to locate the male at a South Burlington hotel where he was taken into custody.
- During the week of April 29th-May 3rd, Officer Jacob Hansell was assigned to the Vermont Police Academy as a training assistant for the ongoing class of police recruits. This in an honor for members of area law enforcement agencies to be chosen to be a training assistant.
- During the week of May 4th-May 10th, Officer Joshua Hansell was completing one of his required two weeks of duty for the Vermont Air National Guard. He will complete the second

week sometime in July at an out of state base. Officer Hansell was recently promoted to the rank of Sergeant with the Air Guard.
