- 10/12/2017: A search warrant was granted by the court for the vehicle seized on 10/07/2017. A search of the vehicle was conducted and the following items were located; 7+ grams of crack cocaine, 12 bags of heroin, 7 prescription pills, 2 grams of marijuana, \$857 cash, a loaded hypodermic needle, paraphernalia and a forged inspection sticker. Additionally it was determined that the female operator's required ignition interlock device was not properly installed in the vehicle. The female was processed and released on citation for sale or crack cocaine, possession of heroin, possession of stimulants and operating with a criminally suspended license. Her cellular phone was seized and a search warrant was granted to obtain additional evidence to support the sale of crack cocaine charge.
- 10/13/2017: Cpl. Hamlin received a report of a suspicious male who had knocked on the door of a residence on Huntington Road and appeared to have been assaulted. Cpl. Hamlin located the male who appeared to have several fresh injuries and was highly intoxicated. It was determined that the male had fled a drinking party that had been broken up in the area and sustained the injuries in the process. He was evaluated by Rescue and transported to ACT 1 in Burlington where he provided a breath sample indicating a BAC of 0.224%.
- 10/13/2017: Cpl. Hamlin stopped a vehicle on Governor Peck Road for speeding. He observed several indicators of impairment from the male operator. The male operator was screened and ultimately provided a roadside breath sample of 0.130%. He was taken into custody and transported to Richmond Police Department for processing. At the completion of processing he was given a courtesy ride to his residence in Jericho where he was released into the custody of his wife.
- 10/14/2017: Cpl. Hamlin received a report of a suspicious male going door to door on Jericho road looking for gasoline. It was determined that the male had broken down on Interstate 89 near Exit 11. He was given a courtesy ride back to his vehicle after getting gas. Upon identifying the male Cpl. Hamlin learned that officials in the state of Maine were attempting to locate the male due to possible mental health issues reported by family members. Cpl. Hamlin reported making contact with the male to Maine State Police. It was collectively determined that the male was not a threat to himself or others and was released.
- 10/15/2017: I received a report of an assault that had taken place between 2 females at a residence on Kenyon Road. This residence has been the focus of an ongoing landlord/tenant dispute. Upon arrival I conducted an investigation that revealed the female tenant had attempted to strangle the female landlord. She was taken into custody and processed at Richmond Police Department for Simple Assault. The female was intoxicated so she was transported to the Chittenden Regional Correctional Center to undergo detox. The female tenants boyfriend who was also on scene and intoxicated began making threatening statements

toward myself and Cpl. Greenough after his girlfriend was taken into custody so he too was taken into custody and transported to Chittenden Regional Correctional Center to undergo detox.

- 10/18/2017: Cpl. Hamlin was conducting stationary RADAR on Governor Peck Road where he clocked a vehicle traveling 72 mph in the posted 35 mph zone. Cpl. Hamlin conducted a traffic stop on the vehicle and subsequently took the male operator into custody for Careless and Negligent Operation. The male was processed at Richmond Police Department and cited to appear in court the following day due to being from the state of Connecticut and having no ties to the community.
- 10/19/2017: As a result of an investigation into an assault that had taken place on Bridge Street, Cpl. Bullock met with the male suspect at Richmond Police Department and processed him for simple assault.
- 10/20/2017: Chief Buck was involved in a vehicle pursuit of a male and female who were suspected by Vermont State Police of several recent burglaries in the area. During the pursuit Chief Buck suffered a serious medical emergency. Luckily he knew something was wrong and was able to pull his vehicle safely to the shoulder on Main Road in Huntington. Due to quick response from a Vermont State Police Sergeant and Richmond Rescue, Chief Buck received the immediate emergency medical care that saved his life. He was treated at University of Vermont Medical Center where he underwent several medical procedures. I am very pleased to report that Chief Buck has been discharged from the hospital. He is currently home resting and recovering.
- 10/21/2017: Cpl. Hamlin received a report of a fight going on between 2 males at the Cumberland Farms. Prior to his arrival all parties had fled the scene. Cpl. Hamlin later received a call from the father of one of the parties involved reporting the incident. Cpl. Hamlin met with the male at the UVMHC ER. An investigation determined that the male had been attacked by the other male after making a statement about a family member which he took exception to. Cpl. Hamlin identified the assailant and met with him at his home in Richmond. The male admitted to the assault and was issued a citation to appear in court to answer to the charge of simple assault.
- 10/22/2017: In the early morning hours Cpl. Hamlin received a report of an alarm at Camel's Hump Middle School. On arrival it was determined that a suspect had drilled out the latch on the window of the Nurse's Office and attempted to steal items. With the assistance of Williston Police Department the suspect's vehicle was located at Riverview Cemetery at which time they observed a male fleeing the area on foot. The male later called from Cumberland Farms and turned himself in. He was processed at Richmond Police Department and cited for Burglary. The male is currently on probation out of Washington County for 2 prior burglary convictions. His probation officer was contacted. His probation was revoked and he was transported to the Chittenden Regional Correctional Center. He was then transferred to the North West Correctional Facility where he is currently being held. The exemplary police work by responding officer's assisted Vermont State Police in tying the male to another burglary that had taken place at Brown's River Middle School earlier that evening.
