- October 12, 2016@ 12:00 hours, Cpl. William Bullock assisted the local Humane Society investigator with an animal cruelty case that they received regarding the mistreatment of horses. This case is on-going.
- October 12, 2016@ 20:53 hours, Cpl. Rick Greenough assisted the Williston Police Department with scary clown complaints. Clown(s) knocked one homeowner's front door and began chasing them armed with a handgun. The responding officers were not able to locate the clowns who had fled the scene.
- October 14, 2016@ 19:44 hours, Cpl. Brett Lindemuth (shift) and Cpl. Rick Greenough (working O.T. detail) backed up the Vermont State Police on Bert White Road in Huntington with an on-going domestic assault and later a deer jacking incident at the same home. Case was being investigated by both VSP for the assault and Fish & Game for the jacking violation. Supplemental affidavit was prepared and turned over to investigators.
- October 15, 2016@ 19:17 hours, Officer Mat Nadeau assisted the Richmond Fire Department on Huntington Road with a car fire that completely destroyed the vehicle. There were no injuries to the occupants who had just gotten the vehicle back from a body shop two days prior.
- October 19, 2016 early evening, Officer John Hamlin assisted the Hinesburg Police Department with a runaway juvenile along with reports of alcohol and drug use and an assault. A male was taken into custody for the assault on scene by Hinesburg P.D. and the runaway juvenile was not located on site.
- October 19, 2016@ 00:01 hours, Officer John Hamlin assisted the Vermont State Police and Richmond Rescue with an emergency medical call on Ayers Drive in Jericho. A 45 year old male suffered a cardiac event and was being rushed to the hospital where he was pronounced deceased a short time later. John assisted rescue get their gear and supplies into the house and later moved and secured their vehicles while VSP escorted the ambulance to the emergency room.
- October 22, 2016@ 20:00 hours, Officer John Hamlin assisted Vermont State Police and Richmond Rescue at Main Road and Sherman Hollow Road with a combative DUI accident suspect. The male is known to this agency and has been arrested by us on multiple occasions. At the time of the call there were only three Troopers on to cover the county so one VSP member stated at scene to handle accident while one Trooper and John proceeded to the emergency room with Rescue were the operator was charged with numerous violations.
- While returning from the above call, Officer Hamlin was enroute back when a call came in of a vehicle off the road on Interstate 89 near mile marker 73/80. The vehicle which was occupied with 4 Chinese exchange students from Canada with limited English skills. A local tow truck was contacted which removed the vehicle and arrangements were made for them to get other transportation.
- October 22, 2016@ 22:37 hours, Officer Hamlin again assisted the Vermont State Police with an intoxicated female in Huntington who had driven off the road. Troopers were still tied up with the DUI accident and a call in Cambridge at the time. When John arrived at the site the vehicle

was gone but he could see evidence of where it went off the road and hit a sign. A BOL was aired but the vehicle was not located.

- October 23, 2016@ 13:31 hours, Cpl. Rick Greenough was requested by Burlington P.D. to contact a male at a Robbins Mountain Road home and serve him with a trespass notice for a Burlington location. After repeated attempts the male was located on October 23<sup>rd</sup> and was issued the notice of trespass.
- October 23, 2016@ 21:20, Officer Mat Nadeau handled a disabled vehicle call on the interstate near mile marker 76/40 as VSP was tied up. A tow service was summoned and the car was removed from the highway.
- October 24, 2016@ 14:31 hours, Cpl. Rick Greenough was requested by Burlington P.D. to attempt to contact a man at a Huntington Road home regarding a hit and run accident. Initial attempt by Cpl. Greenough was unsuccessful, however Officer John Hamlin located the male later in the evening and the message was delivered.

#### **TOTAL INCIDENTS REPORTED: 49**

- October 12, 2016@ 00:54 hours, Cpl. Rick Greenough conducted a motor vehicle stop on West Main by Baker for defective equipment. The 20 year old male was ticketed for minor consuming alcohol as he blew a roadside test of .068%. His vehicle was towed by a local tow service.
- October 13, 2016@ 13:31 hours, I was flagged down by a Huntington Road resident who operates a farm stand with an honor box for those who purchase items. He wanted to advise that on the day prior a vehicle pulled into the yard with a white haired male who attempted to walk off with the cash box until the owner yelled at him at which time he put the cash box back. The only description was a white male approximately in his 50's with white hair about 5"10" driving a gray colored older SUV possibly a Jeep or Chevrolet with an unknown registration.
- October 14, 2016@ 07:02 hours, Cpl. Brett Lindemuth handled a juvenile problem at Camel's Hump Middle School. Seems the school student had made threatening remarks about doing harm to the school and students. The student was interviewed by Cpl. Lindemuth and staff and has since been expelled from the school.
- October 15, 2016@ 10:59 hours, Cpl. William Bullock took a theft complaint from one of the area stores. Sometime the evening prior \$115.00 was stolen from the register. Corporate will review their video for possible suspect(s).
- October 17, 2016, Cpl. Rick Greenough completed an investigation from earlier where the operator fled the scene. The operator was identified and charged with leaving the scene of an accident. Due to his young age and lack of record the case was referred to the Williston/Richmond reparative board for action.
- October 18, 2016@ 03:00 hours, Officer John Hamlin was called to an apartment complex located on West Main Street for a noise disturbance report. Caller advised it sounded like a group partying which woke him up. The exact location could not be

determined by the caller and Officer Hamlin could not locate any disturbance in the area when he arrived a short time later.

- October 19, 2016@ 08:00 hours the traffic light at the four corners malfunctioned. It would not turn green for traffic coming off Jericho Road or Bridge Street. The Vermont Department of Transportation was notified and I directed traffic at the intersection for 45 minutes to clear traffic and then switched the lights to blinking. Over that and the next day A.O.T. came out three times to work on the signal.
- October 21, 2016@ 11:02 hours, Cpl. William Bullock took an identity theft from a Richmond resident. The man's name and social security number were hacked from the Vermont Health Connect database which did report hundreds of hacked files.
