#### Public Hearings:

Robert and Joy Reap - Application #16-129 for a Minor Subdivision Amendment

(Boundary Line Adjustment) between WM0830 and WM0840 and a Preliminary and Final Subdivision Review for a 3-lot Subdivision at WM0830 (for the creation of 2 additional lots.) The affected properties located at 830 and 840 West Main Street are owned by Robert & Joy Reap and are located in the Gateway Commercial Zoning District.

David opened the hearing, and recused himself, Bender swore in the applicants.

Reap provided an overview of the project, they are not asking for approval for the new buildings or the new parking areas, or the driveways, just for the road extension and for the creation of the new lots and boundary line adjustment. Discussion about the adjustment – the reason for the boundary line adjustment (BLA) is to provide a larger buildable area for lot 4. Willis Farm Road will be a private road.
