Hi Josh: Two SB funding requests from the ACF Fund. Last night, on 4/26, the ACF committee voted to recommend spending:

- Up to \$800.00 of ACF funds to hire a Todd Liberty to saw 23 +/- logs of hemlock on the landing into dimension lumber to be used on the ACF for trail bridges, sign posts, etc. (See below)
- \$450.00 of ACF funds to hire Chris Haggerty of Button Surveyors to find or set 4 survey pins on the ACF and Maplewind Farm boundary line. (I'm waiting for Chris to confirm last fall's price of \$450.00 is still good.) (See attached.)

Here is Info on Hemlock Logs:

Approximately 23 Logs that will be cut.

Each Log is approximately 10' long and averages 12" in diameter.

We will be cutting the logs into the following specifications for future bridges:

4x4 Posts for bracing/stringers and 1x6x10 for decking

Approximately 1,380 board feet X \$.35/bd ft = \$483 + \$75 set up Fee

Total cost about \$558. We may get some more board feet so that is why I am asking for a bit more money, but definitely will not be more than \$800.
