The legal voters of the Town of Richmond Vermont are hereby notified and warned to meet at Camels Hump Middle School, in said Town, on May ____, 2021, to vote the following by Australian ballot between the hours of seven o'clock in the forenoon (7:00 a.m.), at which time the polls will be open, until seven o'clock in the afternoon (7:00 p.m.), at which time the polls will close, to vote on the following article(s) by Australian ballot:

Article 1. Shall the voters residing within the expanded Water and Sewer District approve the expansion of the Town's Water and Sewer District westerly to and through [address] West Main Street (U.S. Route 2) and including the Gateway Zoning District, which expansion shall include but not be limited to [addresses] West Main Street (U.S. Route 2) and __ Willis Farm Road [anywhere else?]

Article 2. Shall general obligation bonds or notes of the Town of Richmond in an amount not to exceed _____ Million ____ Hundred _____ Thousand Dollars (\$____,____,000), subject to reduction from available state and federal construction grants-in-aid and other financial assistance, be issued for the purposes of financing the cost of extending municipal water and sewer lines into the Gateway Zoning District [and westerly as far as Riverview Commons Mobile Home Park], the aggregate estimated cost of such improvements being ____ Million Hundred ____ Thousand Dollars (\$____,____,000)?
