7:50 Request for CRF funds from Trails – Old Jericho Road Bridge Engineering application

RTC submitted an application to the RCC to fund an engineering plan for a bridge that had been washed out during the summer flood. Callie provided a brief overview. Discussion ensued.

Part of the Old Jericho Road is on private property. The question arose as to whether the bridge is on the part of the road that is on private property.

Callie said that she thinks that the bridge is on the public part of the road but will need to check on this and get back to us. She also relayed plans to hire expertise to do an engineering plan so that the bridge (and trail) would be much more resilient for future flooding.

This application would just be for the engineering site plan. Another application for the actual construction would come later on.

Ibit brings up the question of whether this area should continue to have a trail? This may be something that Stone Environmental can help assess. Jeanette adds that it's important to look at this trail holistically and decide whether it is possible to rebuild this entire trail. The bridge is just one component of the entire trail. If there isn't a safe trail then there is not much use in having a new bridge.

We may need to bring professional trail builders in to rehabbing the trail. There has been massive erosion and there is very little space to work with in certain spots. And there isn't a way that the trail could keep to just one side of the stream.

Bob asks the question about whether RTC would be required to get bids for this plan rather than just being able to contract with one organization.

Dan Wolfson asks a question about bridge design. What would be the impact of getting equipment into the site? Is there a way the bridge can be built that is lower impact? It may be possible to build the bridge by hand and to limit any further erosion by removing material while creating the bridge.

#### Next steps:

RTC will look into a more expansive project proposal to look at the feasibility of a trail within the Old Jericho Road. Rather than just looking at the bridge.

RTC will also look into the private parcel that is on the north end of Old Jericho Road.

RTC will get back to RCC with an amended proposal.

RTC will ask the town to see if they require bids based on the cost of the proposal.

RTC to discuss. with the State (ANR) given its regulations and permit requirements for riparian areas.

RTC to check with Zoning Administrator / DRB in terms of Zoning Bylaw requirements.

The application will be tabled until next time.
