## Richmond's Conservation Reserve Fund

- 2005: Established by voters for five years
- 2010: Renewed by voters
- 2015: Renewed by voters (Yes 693; No 223)
- 2020: Funding expires

## Richmond's Conservation Reserve Fund

- Financed by 1 cent on the tax rate.
- FY 2020 yield: \$46,465.
- Focuses on conserving local natural, agricultural and historic resources.
- Enables the Town to move quickly to capture time-sensitive funding opportunities.

## Richmond's Conservation Reserve Fund <u>Decision- Making</u>

- Conservation Commission reviews projects proposals on continuing basis.
- Recommendation to Selectboard.
- Selectboard approves or disapproves expenditures.

## **Built-In Fiscal Protections for the Town**

- Design encourages non-profit and volunteer responsibilities for project initiation, management and stewardship.
- Minimizes Town's administrative burdens and expenses.
- "...Any acquisition of a parcel of <u>real estate</u> by the Town, meaning acquisition of a whole parcel and not solely its development rights, requiring in excess of \$20,000 from the reserve fund will require approval of the voters."

- "Maintain Richmond's rural character and scenic beauty."
- "Utilize best management practices for Richmond-owned, publicly accessible natural and recreational areas."
- "Utilize the conservation reserve fund to protect important
- natural resources and public access to them where appropriate"







# But what about Taxes? The Evidence

- Towns with more conserved acreage have lower property taxes.
- Conserved properties demand fewer municipal services.



## It's time to again hear from the voters

- CRF funding expires in 2020
- Richmond Conservation Commission requests the Selectboard to:
  - Put another 5-year CRF renewal before the voters on Town Meeting Day 2020
  - Retain basic article as passed in 2005, 2010 and 2015 (change dates and \$\$ yield)
  - Schedule public hearing
  - Send informational mailing prior to vote
  - Conduct all-day vote by Australian Ballot

## The Question On Town Meeting Day

## **DRAFT**

**ARTICLE** . Shall the Town of Richmond continue funding the Conservation Reserve Fund established by the voters in 2005, and renewed in 2010 and 2015, for the purpose of preserving water quality, providing outdoor recreational opportunities, protecting wildlife, and conserving important natural, agricultural and historic resources, with funding maintained at one cent on the Municipal Tax Rate for five years beginning in fiscal year 2020-2021? One cent on the tax rate, which is equal to \$10 per \$100,000 of assessed value, will yield \$46,465 for the Reserve Fund in FY2020. The Selectboard will administer the fund after considering recommendations by the Conservation Commission. Any acquisition of a parcel of real estate by the Town, meaning acquisition of a whole parcel and not solely its development rights, requiring in excess of \$20,000.00 from the reserve fund, will require approval of the voters.
