19 Rock reported on the following:

- 20 - Local Motion Pedestrian Pop Up Project – this was implemented the past
21 week with 3 volunteers from the Trails Committee. Unfortunately it rained the
22 following day and compromised the temporary crosswalks.
- 23 - Water Quality meeting summery – Rock provided an update on the recent
24 water quality meeting held in Richmond and hosted by the CCRPC. CCRPC
25 will be helping Richmond undertake a Stormwater Management Plan, to help
26 meet the requirements of the Clean Water Act (Act 64), CCRPC gave a
27 presentation on this topic. The State will also be undertaking a update to the
28 Winooski Watershed Tactical Basin Plan, Karen Bates, Watershed
29 Coordinator was present to talk about this process. They wanted to solicit
30 information from town. Rock distributed the handout “Information Request to
31 Municipalities” from CCRPC, the CCRPC would like to have town input on
32 where there are water quality related projects happening in town. Alex asked
33 if the handout with the CCRPC presentation was available electronically,
- 34 - DRB Update on the Cochran’s Application – Rock briefly mentioned that
35 Cochran’s would like to ask the DRB to better define a “Recreation Facility”
36 and would like to host a more diverse range of year round activities at their
37 property.
