- November 13, 2013@ 16:15 hours, Officer Brett Lindemuth stopped a vehicle on Bridge Street for exceeding the 25 mph speed zone and for plates not assigned to the vehicle. The male operator of the vehicle was found to be under a criminal suspension to operate as he had 5 prior convictions for civil suspension. He was processed and released on a citation to appear in Chittenden Superior Court.
- November 16, 2013@ 17:21 hours, Cpl. Jake Hansell took a complaint of a missing hunter who was last seen entering the woods off Snipe Ireland Road. A search was about to commence with members from the Vermont State Police and Richmond staff when the hunter was located. He required no medical assistance.
- November 21, 2013@ 19:56 hours, Cpl. Jake Hansell was called to Stage Road for a family fight. Investigation determined that the husband assaulted his wife resulting in some head injury. The male party was taken into custody and processed at the office on a charge of domestic assault. He was taken to the Chittenden County Correctional Center where bail was set at \$2,500.
- November 24, 2013@ 09:36 hours, Officer William Bullock investigated a complaint of a motor vehicle doing "doughnuts" on Volunteers Green between the soccer nets near the treatment facility. The teenage (16) male suspect was later identified and admitted the offence. He was issued a Vermont Civil traffic ticket for trespass with a motor vehicle with damage. Highway was contacted regarding the damage and it will be repaired in the spring.
- November 27, 2013, Officer Brett Lindemuth as part of an ongoing larceny investigation at Richmond Terrace cited a resident into Vermont Superior Court to answer a charge of accessory before the fact. Initial another resident had been charged with the actual theft of the property.
- November 30, 2013@ 23:14 hours, Cpl. Jake Hansell stopped a suspicious vehicle on Rogers Lane. The female operator was arrested for operating a motor vehicle while under the influence of alcohol. A breath test was administered which registered a BAC of .223%. She was processed and released on a citation to answer a charge of DUI. She will appear in Chittenden Superior Court.
- December 7, 2013@ 20:59 hours. Officer Lance Martel & Cpl. Jake Hansel responded to a motor vehicle accident near the intersection of East Hill and Christmas Hill Roads as a car had collided with an occupied home. Investigation determined that the male operator was under the influence of alcohol. A breath test on the subject registered a BAC of .283%. He was processed and issued a citation to appear in Chittenden Superior Court to answer a charge of DUI second

offence. While Officer Martel & Cpl. Hansel were tied up with this a theft complaint came in from the Bridge Street Café in which an employee's wallet was stolen. Members of the Williston Police Department responded to the café and handled the initial complaint. It was later learned on December 10, 2013 that a small safe was also stolen that contained employee records. The safe was located off Jericho Road with the records still intact and returned to its owner. A suspect has been identified and the case is pending.
