- August 27, 2013@ 20:35 hours, Officer Rick Greenough took a complaint of a male subject drinking alcohol. Subject was taken into custody for violating his court ordered release conditions and was lodged at the Chittenden County Correctional Center.
- August 29, 2013@ 11:41 hours, Officer William Bullock was called to a local business when it was determined that a local male had purchased alcohol in violation of his court ordered release of conditions. He was taken into custody and later arraigned at the Chittenden County Superior Court. This is the same male that Officer Greenough arrested on the 27th and the police department has now arrested this subject approximately 10-12 times in the last couple of months on a variety of charges which include: DUI, violating conditions of release, disorderly conduct and trespassing. He also has numerous charges in this time filed by the Vermont State Police, Shelburne Police and Burlington Police. Since his last arrest by this department he has been ordered into an alcohol treatment facility.

- August 29, 2013@ 21:24 hours, Officer Brett Lindemuth stopped a vehicle on West Main Street for a traffic violation. The male operator was suspected of operating under the influence of alcohol and taken into custody. He was processed for DUI #2 after blowing an evident ray test which registered a BAC of .173%.
- September 1, 2013@ 18:53 hours, Cpl. Jake Hansell responded to a motor vehicle accident on East Main Street near Lilly Pond Circle. Prior to arrival the operator of the vehicle fled the scene on foot. Based on witness statements the operator was tracked to a location off of Lilly Pond Circle. He was taken into custody and charged with leaving the scene of an accident.
- September 3, 2013@ 09:45 hours, Officer William Bullock stopped a vehicle on Cochran Road for speeding, 42 mph in a 25 zone. A record check of the female operator showed that she was currently criminally suspended for a prior DUI charge. She was taken into custody and later released on a citation to appear in Chittenden County Superior Court.
- September 3, 2013@ 22:27 hours, Cpl. Jake Hansell stopped a motor vehicle for running a stop sign coming off the interstate onto West Main Street. A computer check revealed that the male operator was currently criminally suspended for a prior DUI charge. He was taken into custody and later released on a citation to appear in Chittenden County Superior Court.
- September 6, 2013@ 14:24 hours, Officer William Bullock took a complaint of a female operator failing to obey the traffic controllers at the Route 2 bridge construction. She pulled out of a line of traffic squealing her tires and struck a flagger at the site and continued on. When a second flagger attempted to stop her she decided to turn around and head back the way she came but ended up striking a set of guardrails and a second flagger before fleeing the scene. Neither flagger required medical attention due to being struck. Officer Bullock was later able to identify the operator through investigation and witness statements. She is currently in custody in a mental health facility and will be charged with leaving the scene of an accident and careless & negligent operation.
- September 7, 2013@ 11:15 hours, Officer William Bullock was flagged down by a Depot Street resident for a burglary involving no force. Two handguns were stolen but the long guns left behind. A suspect has been identified who is not a family member and currently is located in another state. The weapons stolen have been entered into NCIC and the investigation is ongoing.
- September 8, 2013@ 11:06 hours, Officer Brett Lindemuth was called to a family disturbance in which the male party fled the scene. He had dispatch issued a BOL for the male and his vehicle. The vehicle was spotted by officers from the Williston Police Department in which he initially refused to stop and a slow speed pursuit was initiated. After a short chase the vehicle was stopped and the operator was taken into custody and charged with DUI-drugs. He was later taken to the Medical Center for a mental health screening after threatening to commit suicide.
- September 9, 2013, Cpl. Jake Hansell took a call of a helicopter landing in a field off of Verburg Road. As he checked the area he spoke with the land owner who advised the helicopter was part of a government funded project to seed the field to grow wheat.
