- June 13, 2013@ 18:12 hours Officer Jake Hansell was called to Phoenix Circle for a dispute. A 19 year old male armed with a knife was attempting to slash tires on a vehicle in the driveway. A physical altercation took place and the male was charged with domestic assault and jailed at the Chittenden County Regional Correctional Center.
- June 16, 2013@ 14:30 hours Officer Brett Lindemuth assisted Richmond Fire & Rescue with a female stranded on an island in the Huntington River after overturning her kayak. She was later able to get to shore and her husband retrieved her kayak.
- June 16, 2013 during the afternoon Officer Brett Lindemuth dealt with an intoxicated male who was stumbling down East Main Street by Harrington's. The male blew a .320% BAC. Family members were contacted and the subject was released into their care.
- June 20, 2013@ 15:35 hours Officer William Bullock investigated an embezzlement complaint from the Richmond Mobil. One of the attendants was caught stealing a small amount of cash out of the register and was suspected of stealing an additional \$200. He was fired on the spot after admitting to the small theft. The store chose not to file criminal charges.
- June 18, 2013 Officer Joshua Hansell investigated the theft of a motor vehicle. The vehicle was entered into NCIC and was located the next day at a home in Georgia, Vermont. The female suspect (who has alcohol & drug abuse issues) was charged with operating a vehicle without

- owner's consent and will be in court in July. Officer Hansell had arrested the same female for DUI 1 month earlier.
- June 18, 2013 Officer Lindemuth attended 1 day training in Stowe. The course was an advanced vehicle operations class conducted by The Stevens Driving School and sponsored by the Vermont police Academy.
- June 18, 2013@ 22:29 hours Officer Joshua Hansell conducted a motor vehicle stop. After smelling marijuana a consent search was done in which a grinder and a small amount of marijuana was confiscated. No court action was taken due to the amount.
- June 21, 2013@ 21:35 hours Officer Jake Hansell conducted traffic stop. The female operator was arrested and charged with her second count of DUI after blowing a BAC of .101%.
- June 22, 2013@ 17:17 hours Officer Jake Hansell investigated a single vehicle accident. The
 female operator was determined to be DUI after blowing a BAC of .203%. The female was a
 family friend so Officer Hansell had the Williston Police Department process her for the DUI.
- June 22, 2013@ 02:29 hours Officer Jake Hansell conducted a motor vehicle stop. The male operator, a convicted felon for homicide was taken into custody for DUI #2 after blowing a BAC of .152%.
- June 24, 2013 Officer Brett Lindemuth was investigating the repeated entry into a home on Hapgood Lane in which over \$2,000 worth of property & cash was taken over a 3 month period. An interview was conducted with a 16 year old male suspect with his mother present .A partial confession was obtained and later further statements indicating that the youth had entered the home at least 5 times. He was charged with burglary, 5 counts and will be in court on July 25th to answer these charges. It was determined that the property was sold to support his addiction to drugs.
- Officer Brett Lindemuth is currently investigating a domestic assault that occurred in the last couple of weeks in which the female 17 year old victim sustained a concussion and a broken collar bone from her father. Statements have been obtained and probable cause established and the victim's father will be charged with domestic assault later this week. Also he is investigating a late reported fraud complaint from a local business in which a former employee stole several hundred dollars from the business. She was terminated from the job and is also facing fraud charges by Essex police. She is scheduled to turn herself into Officer Lindemuth on the 26th June and will be processed and cited into court for a single count of fraud by check.
