- August 28, 2013@ 14:59 hours, Officer Rick Greenough dealt with a male who was at the school with a female he was not to have contact with per his court ordered release conditions because of a domestic assault. The male was issued a citation to appear in court to answer a charge of violating his conditions of release.
- August 29, 2014@ 02:08 hours, Officer Lance Martel was advised by dispatch to BOL for a vehicle headed southbound on the interstate toward Richmond and that the vehicle was running without lights on and was all over the road. Officer Martel was able to catch up to the vehicle near mile marker 74. The female operator had no alcohol in her system but was using Lorazepam. A DRE from Colchester Police met Officer Martel at the office and determined that she was impaired. The operator refused to go to the emergency room for a blood draw and she was charged with operating under the influence of drugs and refusal and Careless & Negligent operation. She was released on a citation ordering her into Chittenden County Superior Court.
- August 30, 2014@ 02:40 hours, Officer Lance Martel was headed home when he observed a vehicle on Mountain View Road travelling at 55 mph in the posted 40 zone. He stopped the vehicle and determined that the male operator was under the influence of alcohol. He was taken into custody after a roadside breath test registered a BAC of .110%. An evidentiary breath test several hours later registered a BAC of .097%. He was cited into court to answer a charge of DUI and Careless & Negligent operation.
- September 2, 2014@ 07:09 hours, Officer Brett Lindemuth and myself responded to a single vehicle accident located at 139 Wes White Hill Road. The male operator who was coming down the hill advised he fell asleep. His vehicle went off the right (east) side of the road into a ditch and travelled in excess of 200' hitting a culvert and flying over the top of a driveway before running over the mailbox and post and came to rest in the drainage. A couple of moments later this could have been tragic as the women and her children would have been standing in the driveway waiting for the arrival of the school bus. The male operator was ticketed for failure to keep his vehicle on the roadway and his now totaled car was removed by Blackfork Towing & Recovery.
- September 2, 2014@ 08:21 hours, Officer Brett Lindemuth and myself responded to the Richmond Mobil after dispatch received text messages from a women claiming she was suicidal. Upon arriving at the scene a female was identified as the texter who was with her care giver. This female was under parole conditions that she was not allowed to call, e-mail or text emergency services to include police, fire and EMS and if she needed their services a care taker would make the call. This has been a pattern with this women to make false calls to emergency

responders to include the night before which resulted in emergency service providers looking for her in both Waterbury and St. George. On this day she was in no emotional or physical distress, however we did have rescue transport her to the emergency room for a mental evaluation. She was issued a flash citation by Officer Lindemuth ordering her into court two days later to answer a charge of violating conditions of parole.

- September 2, 2014@ 15:28 hours, I responded to the area of 1060 Dugway Road, the lower gorge with Rescue and fire for a reported male down in the gorge area suffering from a possible medical situation. It turned out the male had been reported missing to the Vermont State Police from Huntington. After 10 years of being sober he went on a two day bender and was highly intoxicated requiring assistance getting back to the road. It appears he had consumed approximately a dozen cases of beer in two days. He was transported to the emergency room by rescue where he was going to be met by a Trooper. I had Blackfork Towing & Recovery come remove his vehicle from Dugway Road.
- September 3, 2014@ 23:121 hours, Officer Matt Nadeau was called to Cumberland Farms about a women acting suspicious. Upon arrival he found the women who had 4 kids with her ranging between age 2-10 was using Pregnazone, Ritalin and Benadryl all at the same time. She was taken into custody for DUI/Drugs and a DRE was contacted which had to come out of the St. Albans barracks. The DRE, Trooper Jay Riggen determined that she was under the influence of drugs. With the assistance of Sgt. Lucas and Trooper Barone of the Williston Barracks arraignments were made to get enough car seats and transportation for the children to the women's boyfriend who was coming from Waitsfield. The operator was taken to the emergency room for a blood draw and because of her state of impairment she was transported to ACT 1 to be held until sober.
