- October 14, 2013@ 07:49 hours, Officer Bullock responded to Tilden Ave for a reported car break in. Sometime over the evening a car door window was smashed and the wallet located inside the driver's compartment was taken. The wallet contained approximately \$40 in cash.
- October 14, 2013@ 10:51 hours, Officer Bullock took a fraud complaint involving \$258.00. It was determined that the incident actually took place in the Town of Hardwick, Vermont. A case narrative was completed and the incident was transferred to the Hardwick Police Department for further investigation.
- October 14, 2013@ 17:17 hours, Cpl. Jake Hansell responded to Stage Road in Jericho to assist the Vermont State Police with a burglary that had just occurred on Nashville Road. The home owner interrupted the female suspect who fled the scene but not before the home owner could obtain the license plate number. The vehicle was tracked to the Stage Road address where Cpl. Hansell located the vehicle and secured the scene until Troopers could arrive. The female

suspect was taken into custody where she was charged with burglary, 2 counts and violated her conditions of release.
