- September 23, 2014@ 20:09 hours, Officer Matt Nadeau located a wanted female on Lower Circle. She had a warrant for her arrest for possession of stolen property out of Burlington. This was the same home where Officer Nadeau arrested another women (sister) on a warrant a few weeks earlier. She was taken into custody and lodged at the regional correctional center in South Burlington.
- September 28, 2014@ 10:43 hours, Officer William Bullock stopped a motor vehicle on Cochran Road for speeding, 59 miles per hour in a 45 zone. The male operator from Huntington was found to be currently criminally suspended. He was issued a traffic ticket for speed and cited into the Chittenden Superior Court to answer the charge.
- September 28, 2014@ 02:17 hours, Officer Lance Martel stopped a vehicle for speeding on the interstate while on his way home. The male operator was suspected of being under the influence of alcohol. After roadside testing the operator was taken into custody for suspicion of DUI. An evidentiary breath test registered a BAC of .147%. He was issued a citation requiring him to appear in Chittenden Superior Court to answer the DUI charge.
- October 1, 2014@ 22:39 hours, Officer Matt Nadeau conducted a traffic stop on Hilltop Circle. While speaking with the male operator he could smell the odor of marijuana coming from the car. A consent search was requested and granted by the operator. Officer Nadeau located approximately 3.5 grams of marijuana in the vehicle. The operator was issued a civil ticket for possession of marijuana.
- October 3, 2014@ 16:50 hours, Officers Lance Martel and Matt Nadeau were flagged down by a women on East Main Street. The female advised that she had been physically assaulted by her former boyfriend who is also the father of her child. She further advised that the male suspect had come to her apartment and smashed out the window air conditioner to gain entry and had gone to the drug store, obtained her prescription medication and refused to return it unless she met certain requirements he imposed. The suspect was located later that evening and was processed at the office. He was charged with aggravated assault disorderly conduct by phone, prescription fraud, unlawful mischief, petit larceny and extortion. He was taken into custody and

lodged at the regional correctional center where he was held on \$1500.00 cash bail. This suspect has a previous assault charge pending that we investigated a few months ago on Jericho Road that involved his sister.

- October 1, 2014@ 22:40 hours, Officer Lance Martel stopped a vehicle on Hilltop Circle for a motor vehicle violation. As he was speaking with the operator he could smell the odor of marijuana coming from the vehicle. A consent search was requested and granted. Officer Martel located 5 separate small bags of marijuana that the operator claimed were for his own use. The operator was issued a civil traffic ticket for possession of marijuana.
- October 9, 2014@ 23:50 hours, Officer Lance Martel made a traffic stop near the Richmond/Bolton town line. The male operator was currently under criminal suspension. He was processed and released on a citation ordering him into Chittenden Superior Court to answer the charge.
- October 11, 2014@ 22:52 hours, Officer Matt Nadeau conducted a traffic stop on Hinesburg Road for a vehicle crossing the traffic lines. While speaking with the operator he could smell the odor of marijuana coming from the vehicle. A consent search was requested and granted by the operator. Officer Nadeau located 8 grams of marijuana along with a bong, grinder and a small digital scale. The operator was screened for DUI-drugs with negative results. He was released with a civil traffic ticket for possession of marijuana.
