- June 27, 2017@ 14:28 hours, Cpl. Rick Greenough assisted a Vermont State Trooper with a vehicle search on Gov. Peck Road.
- June 27, 2017@ 19:54 hours, Officer John Hamlin was dispatched to a single vehicle accident located on West Main Street. When he arrived at the scene he identified the 35 year old male who had been operating a company truck. While speaking with the operator he detected alcohol coming from him and he was screened for DUI. A roadside test registered a BAC of .183% and he was then taken to the office to be further processed. An evidentiary test registered a BAC of .156%. The operator was issued a citation to appear in Chittenden Superior Court to answer a charge of DUI#3 as he has two prior DUI convictions.
- June 28, 2017@ 15:40 hours, Cpl. Rick Greenough was assisting a Chittenden County Deputy Sheriff with a vehicle search on Route 117 when a passing vehicle advised him of a vehicle all over the road. With the description, Cpl. Greenough spotted the vehicle headed toward Essex on Route 117. After developing his own probable cause he stopped the vehicle near the Jericho/Essex town line. While speaking with the 33 year old male he detected alcohol emitting from his breath and also located in the vehicle were his 4 year old daughter and 1 year old son. A roadside breath test registered a BAC of .155% at which time he was taken into custody. The Deputy Sheriff that Cpl. Greenough had been assisting arrived and stayed with the children until a family member could come to the scene. Once at the office the operator refused to take an evidentiary breath test. He was issued a citation for DUI/Refusal and 2 counts of cruelty to children. The Department of Children & Families was contacted who will investigate the children aspect of the case.
- June 29, 2017@ 02:20 hours, Sgt. Nadeau assisted the Vermont State Police with a domestic disturbance located on Bridge Street in Huntington. Sgt. Nadeau and Officer John Hamlin

located the male half at a home located on the Duxbury Road at the Richmond/Bolton border. Troopers arrived a short time later and the male half was cited into court on a criminal complaint.

- June 29, 2017@ 07:58 hours, Cpl. Brett Lindemuth assisted the Vermont State Police with a reported injury accident in Bolton. Cpl. Lindemuth was first on the scene and it was believed that the operator may have been attempting suicide by ramming his vehicle into a tree. Cpl. Lindemuth turned over the information he had collected to the responding Troopers who will be handling the investigation.
- June 29, 2017@ 15:15 hours, Sergeant Mat Nadeau and Officer John Hamlin assisted with the transfer of an elderly female from her home to a court ordered assisted living facility. The women whose self-care and her welfare had been declining for some time. She initially refused to cooperate and had to be sedated by Richmond Rescue after which time she was transported to the hospital for a check and then into the care of Howard Mental Health.
- July 1, 2017@ 00:41 hours, Sgt. Mat Nadeau observed a vehicle on Route 117 swerving in the road. He stopped the vehicle on Route 117 near Rogers Lane and spoke with the 36 year old female operator and male passenger. Sgt. Nadeau determined that she was under the influence of alcohol; however she refused both the roadside test and the evidentiary test. The male passenger was screened to see if he could operate but he registered a BAC of .146% on the roadside test. She was processed and cited into court to answer a charge of DUI/Refusal.
- July 1, 2017@ 18:10 hours, Officer John Hamlin responded to Bridge Street to assist two Vermont State Game Wardens dealing with an adult couple highly intoxicated to the point the female could not stand. The wardens ended up arresting the 48 year old male for disorderly conduct and the female was taken into protective custody and transported to ACT 1 in Burlington by a Trooper. While Officer Hamlin was transporting the male to the jail he attempted to kick out one of the side rear door windows. There was their 9 year old daughter who needed to be cared for and when one of the wardens went to the grandmother's home she was located inside on the floor as she had fallen breaking a hip. Rescue was contacted as was the Department of Children & Families.
- July 2, 2017@ 09:36 hours, Cpl. Rick Greenough responded to a single vehicle rollover accident on Huntington Road near Besaw Road. When he arrived at the scene the 53 year old male operator was still inside the vehicle which was resting on its side. The operator who was checked at the scene by rescue was screened for DUI as a strong odor of alcohol could be detected coming from him. A roadside breath test registered a BAC of .246% and a later evidentiary breath test registered a BAC of .237%. He was processed at the office and cited into Chittenden Superior Court to answer a charge of DUI.
- July 2, 2017@ 12:49 hours, Cpl. Rick Greenough assisted the South Burlington Police with locating a 16 year old missing/runaway male. Information was obtained that he had been partying at a home in Richmond. After speaking with the juveniles at the home (no parents) who initially denied he was there he was located in the backyard. Cpl. Greenough transported him to South Burlington where he was turned over to South Burlington Police.

- July 3, 2017@ 13:13 hours, Cpl. Rick Greenough assisted DCF with an unannounced home visit at a W. Main Street residence. This was in regards to the case listed above with the two highly intoxicated people that Officer Hamlin and the State Wardens dealt with.
- July 4, 2017@ 18:03 hours, Sergeant Mat Nadeau conducted a traffic stop on Route 117. A check of the 26 year old male's record showed that he was currently criminally suspended and that there were two outstanding arrest warrants for him. The warrants were for failure to appear in court on DLS-C charges and possession of narcotics with bail set at \$800. He was taken into custody, processed at the office and cited for the DLS-C charge and then transported to jail on the two arrest warrants.
- July 4, 2017@ 21:32 hours, Cpl. William Bullock and Rick Greenough assisted Richmond Rescue on Bridge Street as they attended to a male who suffered a heart attack and collapsed in the street. Rescue had to use an AED to get his heart back into rhythm and he was transported to the emergency room. We then were able to locate his wife after announcing on the bands microphone at the events on the green and Cpl. Greenough ended up transporting her to the emergency room as her husband had the car keys in his clothing.
- July 6, 2017@ 13:42 hours, dispatch took multiple calls from a male who claimed he was being chased by hit men shooting at him. This was occurring on both Route 2 and the Interstate as he was driving around in circles. Finally Cpl. William Bullock was able to make contact with the male who was having mental health issues and has a history of mental health issues. Cpl. Bullock transported the male to the emergency room for a mental health exam and when they arrived he wanted to run inside because the hit men were still after him. Later Cpl. Bullock located where he had contacted some heavy equipment at the CAT dealership breaking glass on his car.
