**Incidents:**

- On 10/23/18 Cpl Bullock responded to a suspicious complaint at Richmond Home Supply. Upon arrival he found a bunch of string attached to the front door handle with \$3 and a note thanking them for the use of a cutter and string. The owner was advised.
- On 10/24/18 Officer Pecor, Cpl Bullock and I responded to a residence located on Stonefence Road for a report of a residential burglar alarm. Residence was found to be secure, false alarm.

- On 10/24/18 Cpl Bullock responded to a different residence on Stonefence Road another alarm activation. The residence was secure, false alarm.
- On 10/25/18 Cpl Bullock responded to Stage Road for a report of a male in an orange jumpsuit running into the woods. Cpl Bullock made contact with a female wearing a pink pajama jumpsuit, who was out for a walk to have a cigarette and went into the woods because she was scared of the passing cars.
- On 10/25/18 Cpl Bullock assisted the Internet Crimes task force with a search warrant on West Main Street. The subject of the warrant was not at home.
- On 10/25/18 Cpl Bullock was requested to check on a suspicious male on the Huntington side of Gillette Pond Rd as all troopers were tied up. The male reportedly had his pants down around his ankles. The male was gone upon arrival.
- On 10/25/18 Cpl Lindemuth located a vehicle that was the subject of a Be On the Lookout (BOL) for a possible intoxicated operator. He initiated a motor vehicle stop and determined that the operator was not impaired.
- On 10/26/18 Cpl Bullock responded to a residence on Hinesburg Road for an attempted burglary. The homeowner returned home and found that someone had attempted to gain entry into the residence via the front door, damaging the door to the extent that the lock needed to be replaced. Entry to the residence was not obtained, no suspects at this time.
- On 10/26/18 Cpl Lindemuth Assisted the ICAC task for serving the warrant on the subject on West Main Street. The subject was located, transported to the Richmond Police Department for processing then released on a citation.
- On 10/27/18 Cpl Bullock participated in the "Big Truck" event at Richmond Elementary School.
- On 10/30/18 Cpl Bullock located an elderly male walking on Cochran Road. The man suffers from dementia and had wandered away from his residence. Bullock transported him back home.
- On 10/31/18 I passed out Halloween Candy on Pleasant Street along with Richmond Fire and Rescue.
- On 10/31/18 I responded to Huntington Road for a report of a bear struck by a motor vehicle. Upon arrival I found the deceased bear along with the operator of the truck that struck the bear. The crash was unavoidable as the bear jumped over the guardrail and came out of nowhere. There was no damage to the bear. After checking with fish and game, the bear was given to a passer by.
- On 11/02/18 Cpl Lindemuth responded to the park and ride for a possible car fire. Upon arrival he found plumes of smoke coming from the engine compartment. Lindemuth determined the smoke was actually steam coming from an overheated radiator.
- On 11/03/18 Cpl Bullock responded to a residence on Wortheim Lane for a motion alarm. Bullock found the residence secure.
- On 11/04/18 Cpl Bullock responded to a threatening complaint on East Main Street. The complainant advised that someone she was chatting with on Facebook threatened to "stab" her and "crush" her baby's head. Cpl Bullock

made contact with the person making the threats and explained the consequences of making such threats.

- On 11/04/18 Cpl Bullock responded to a residence located on Gov. Peck for a report of a citizen dispute at the residence. After some investigation Cpl Bullock learned that a teenage female had gotten into an argument with her boyfriend, which resulted in her slapping the boyfriend and breaking the door and window. Cpl Bullock met with the female and her mother at the police department and took a statement. Due to the age of the suspect and the conflicting statements given by the parties involved, Cpl Bullock sent the case to the state's attorney for review, more to follow.
- On 11/07/18 Cpl Bullock responded to a residential alarm at a residence located on Locust Knoll. Residence was checked and found to be secured.
- On 11/07/18 Officer Pecor responded to a report of a car vs. deer crash. Upon arrival the deer was gone, minimal damage to the car and no injuries to the operator.
- On 11/09/18 Cpl Lindemuth responded to a report of a motor vehicle collision on River Road. One vehicle was totalled, the other towed from the scene with front end damage. There were no injuries. A vehicle coming off Gov. Peck collided with a vehicle traveling west on River Road.
- On 11/10/18 Cpl Bullock responded to a vandalism complaint on Meadow Lane. A rock was thrown through a vehicle window. Appears to be a strict case of vandalism as there was nothing missing from the vehicle, nor any proof that it had been entered.
- On 11/11/18 I met with a resident of East Main Street who wished to report a fraud. The resident had moved to Richmond last week to live with his sister as he is terminally ill. Before leaving North Carolina he was hospitalized and signed over power of attorney to his daughter, who also lived in N. Carolina. The daughter emptied his checking and savings accounts. As the crime occurred in North Carolina there was not much I could do from here. I sat with the victim and explained his options and assisted him in locating contact information for the police in Raleigh, North Carolina.
- On 11/11/18 Officer Pecor responded to a report of a car vs. Deer motor vehicle crash on Huntington Road. There were no injuries and minor damage to the vehicle.
- On 11/12/18 Cpl Bullock Initiated a motor vehicle stop on Route 2 and discovered that the operator was criminally suspended for life. The operator was taken into custody, transported to the Richmond Police Department for processing and released with a citation for Criminal DLS.
- On 11/12/18 Officer Pecor conducted a welfare check on a juvenile who made suicidal statements to a classmate at MMUHS. Officer Pecor spoke to both the juvenile and a parent and confirmed that they were statements made in the heat of the moment while in an argument with a friend. The parent of the student felt that there was no need for further assistance, but would contact the police if more was needed.
