- September 27, 2013- On July 2, 2012@ 04:50 hours Chief Buck was called to a burglary at the Kitchen Table Bistro located at 1840 West Main Street. A thief entered the business by breaking out the door glass of a rear door and then kicking open an interior door. When the suspect broke the glass in the door he cut his hand or arm leaving blood samples on the door lock and inside the building. The blood samples were collected as evidence and submitted to the forensic lab for DNA analysis. At the time of the theft a \$1,200 cash register was stolen and \$300 worth of damage was done to the door. On September 27, 2013 the lab sent a notice that a match had been obtained and a suspect identified. The suspect was later located at his place of residence in South Burlington with the help of detectives from S. Burlington Police. This suspect was currently out on 24 hour electronic monitoring for several other crimes to include assault & robbery, Possession of drugs and burglary. He was charged with the July 2, 2012 burglary and will be arraigned in November.

- September 29, 2013@ 18:00 hours, Cpl. Jake Hansell investigated the theft of a catalytic converter that was cut from a vehicle that was located at the Park & Ride on Route 2.
- September 30, 2013@ 08:40 hours, Chief Buck investigated another theft of a catalytic converter that had been cut from a vehicle located at the Park & Ride on Route 2. The night shift has been making repeated patrols through the Park & Ride since these two incidents.
- September 30, 2013@ 14:51 hours, Cpl. Jake Hansell initiated a traffic stop on West Main Street after a vehicle was observed spinning its tires after leaving a business located near the intersection with Bridge Street. Cpl. Hansell could smell an odor of marijuana coming from the vehicle and a consent search was requested. 4 grams of marijuana was located and the operator was issued a civil traffic ticket for possession of less than 1 ounce.
- October 4, 2013@ 20:29 hours, Officer Brett Lindemuth was called to a camp located on Snipe Ireland Road for a dead body. Officer Rick Greenough was contacted as he is our certified death investigator and he proceeded to the scene. The medical examiner's office and the states attorney's office were contacted per protocol. The 72 year old male was discovered on the porch of the camp and had been there for several days. Working with the medical examiner's office it was determined that the victim died approximately 2 days earlier and had suffered a stroke.
- October 6, 2013@ 00:18 hours, Cpl. Jake Hansell was called to Rodgers Lane for an intoxicated male at the home who did not belong there. After arriving a few minutes later the male suspect had fled to a home located on Route 117 where he was confronted by Cpl. Hansell. The subject, known to us was arrested for violating his court conditions on previous charges by this agency. He was at a home the court barred him from and was driving while criminally suspended and had been drinking alcohol, also in violation. Located in the home was a 1 year old and an 8 year old without any adult supervision. The two children were taken into protective custody with the help of Williston Police. Attempts by dispatch to reach the mother by phone were unsuccessful and the Department of Children & Families was contacted. A separate affidavit was prepared by Cpl. Hansell for Child in need of supervision and a judge was contacted. The 1 year old was ordered into the custody of DCF and the 8 year old was released to his father. The original suspect was lodged at the jail on his charges. This made for a very long shift for Cpl. Hansell who had come on at approximately 15:00 hours and did not finish with the case work and lodging until approximately 05:00 hours the next morning.
