Jim is the chair of the RLT Stewardship Committee. He has been gathering information about the usage and value of the Bombardier Meadow and the Beeken canoe access. He spent some time with two folks from the VT Fish and Game Department about river access and fishing usage.

We shared with Jim the status of potential other recreational parking in the Jonesville area and expressed the importance the Bombardier Meadow has been for safety and accessibility to the river. We also mentioned that if the RLT moved to create a permanent seasonal lot in this meadow, some work would need to be done for the Pugh family who is directly impacted by dust, noise and aesthetics of this parking area.

Jim is compiling these insights and will work informing the RLT in early November 2021. We await their decision of the future of the RLT Bombardier Meadow.
