Arneson: We need to rent those.

Werneke: Can we put up something by the interstate?

Heston: Is this an expense we need to vote on?

Sander: Highway should have some funds available to rent it so we do.

Hill: Lets instruct Highway to use their funds to rent the signs.

Arneson: What is possible to get in the next 24 hours? Where do we put it?

Werneke. Have a sign at interstate exit and across from the Park & Ride.

Hill: Ask police & fire to come up with a plan for traffic control and signage.

Sander: Barbara has a monument by Round Church. We should look into one for Ryan as well.

Hill: Let's put that on the agenda for a future meeting

Werneke: Let's move to close the road. I propose that someone moves the motion.

WHEREAS, Ryan Cochran-Siegle competed in the 2022 Beijing Winter Olympics and won a silver medal in the Super G event

WHEREAS, Ryan Cochran-Siegle brought a welcomed spotlight to the town of Richmond and Cochran's Ski Area

WHEREAS, many Skiing Cochrans have competed for the U.S. Ski Team with Barbara Ann Cochran winning a gold medal in the slalom event in the 1972 Winter Olympics in Sapporo, Japan

WHEREAS, the Cochran family and the Cochran Ski Area have provided thousands of children and families the opportunity to ski and snowboard by creating a uniquely inclusive culture

NOW THEREFORE, the Selectboard of the Town of Richmond wishes to recognize and honor Ryan Cochran-Siegle for his accomplishments in the 2022 Winter Olympics by declaring Saturday, February 19, 2022 to be "Ryan Cochran-Siegle Day" in Richmond, VT and by presenting him with a "Key to Richmond"
