- Q&A before the breakout sessions? This would make sense in answering people's questions before the breakout rooms
- What is the format for the discussion? What about people that have not been following the ACFC closely? Would having the Q&A first give these people enough background information to participate in the breakout group discussion?
- Melissa recommended that one of the ACFC member facilitates the small group discussion
- We could introduce a protocol for how to ask and answer questions, Chase and Jim had a lot of ideas for how to do this
- Instead of multiple topic areas we could all have the same topic areas and every group gets the same group of topics
- We should perhaps give more time for the breakout groups? It is currently at 20 minutes, but maybe it could be 30 instead?

- Need to think about transitions from open house to welcome and power point. And from small group discussion to expert question time.
- What are you excited about, what are you concerned about, what would you change?
 - These could be questions that would guide the small group discussion Is this too specific? Does the public need to be super informed to attend? We want to ask specific questions but we also want the topic to be broad enough that the public can participate.

- Cecelia raises the question of whether we want to quantify our answers. The point of the small group discussion could be that ACFC members are taking notes and writing down takeaway ideas. These ideas get incorporated into the final report, but there doesn't need to be a shareout in which the small groups present some type of unified vision or answer to specific questions.
