# **Introduction and Background**

The Andrews Community Forest Committee (ACFC) of Richmond, VT, seeks the assistance of an expert writer to make revisions to the Andrews Community Forest Management Plan. [Question: 2018 or March 2023 version as the basis?]

(Adapted from RFP for Trails Planning) The Andrews Community Forest (ACF) is a 428-acre parcel purchased by the Town of Richmond VT in 2018 as a Town Forest under conservation easements held by Vermont Land Trust (VLT) and the Vermont Housing and Conservation Board (VHCB). The land climbs from roughly 400 feet in elevation to 1200 feet. Excepting two small meadows, the

parcel is largely wooded with an abundance of hard-mast stands (predominantly oak and beech) and several patches of rare natural communities (e.g., Dry Oak Forest). Recent timber harvesting and blowdown events have created patches of early successional habitat in the west and south of the property. The parcel is at the southern end of a 70,000-acre forested swath that includes Mt. Mansfield State Forest and is therefore part of one of the state's largest, remaining unfragmented blocks. The Vermont Conservation Design <u>prioritization</u> considers the entire parcel to be part of a 'Highest Priority Interior Forest Block' providing critical ecological function on a statewide level. ACF is the latest addition to the long-standing 10,000-acre Chittenden County Uplands Conservation Project. The ACF provides habitat and movement corridors of particularly sensitive species, those that require large interior forest blocks, or those that are otherwise represented in the broader Chittenden County Uplands landscape (e.g., bobcat, bear, mustelids).

The ACF was originally zoned as Agricultural, changed in 2020 to Recreational see <u>variance denial</u> and DRB Decision

The <u>Conservation Easement</u> (pages 6-7) details permitted uses including public access. A <u>Management Plan</u> (MP) for the ACF was approved by the Town's Select Board in 2018. Since then three additions have been proposed: A <u>Trails Plan</u> proposed by Arrowwood Environmental and Sinuosity; an Original People and <u>Land Recognition</u> written with input from <u>Richmond Racial Equity</u> and others; a <u>Forestry Plan</u> drawn up by Chittenden County Forester Ethan Tapper (and SB approved?).

A proposed <u>revised Management Plan</u> was prepared by the ACFC in March 2023 incorporating these additions, and also making additional revisions (<u>Daniel</u> - explain and detail)

#### **Project Description - Tasks**

Both recreation and the protection of natural resources and habitat on ACF are important priorities for the AFC (see <u>Conservation Easement</u> (page 2) and reflected in the Management Plan. Some Richmond residents have expressed concerns that public access on trails and certain trail uses may negatively affect ACF's natural resources and habitat.

indicated the need for further revisions, including some re-organization and updates based on <u>advances in ecological science</u> and benefiting from formats and content in <u>other Management Plans</u> for conserved lands in the region. [more from RCC?]

In 2023 two ACFC subcommittees (named '<u>Trails Stewardship</u>', and '<u>Comprehensive Management Plan</u>') prepared proposals for incorporation into the Management Plan, taking into account the Public Comments.

<u>Trails Planning:</u> The ACFC will advise on a listing of criteria for approving respectively (1) New pedestrians trails; (2) New trails with mechanized (bicycle) use.

#### Clarify Management Vision, Objectives and Actions

Management objectives and actions will address:

- The Vision of the ACFC based on the 'Statement of Purposes' in the Conservation Easement (page 2)
- Management Objectives addressing the above Purposes
- Management Actions addressing each of the above Objectives

#### **Summary of Project**

The purpose this project is as follows: In light of these proposed updates of the MP, the ACFC seeks to hire a person with skills and experience in writing management plans for conserved primarily forested land to incorporate new material and to reorganize existing content for accuracy, consistency and to improve its organization to distinguish between material detailing history and existing conditions and material specific to management policies and procedures. Particular attention should be given to articulating a clear vision for the management of the ACF to motivate statements of 'Management Objectives' and 'Management Actions'.

- Prepare a draft for submission to ACFC that will then solicit written public comments from Richmond residents (the 'public'), Richmond Conservation Commission (RCC), the Richmond Trails Committee (RTC), VLT, and the Richmond Select Board.
- Make final revisions compiled by the ACFC addressing any issues that arise.
