Richmond Town Plan Update

The Planning Commission began its review of Section 5, Natural Resources and the report from Front Porch Community Planning & Design. The Commission briefly discussed the overall layout for each chapter (e.g., goals, objectives, policies, strategies) but did not make any final decision about the layout. In addition, the Commission discussed the General Goals (page 7) for the Town Plan and decided that each of those goals should be revised to cast them in the "active voice" similar to Goal #1. Gent will revise those goals accordingly. The Commission discussed the fact that there are not any goals in the Natural Resources section and that the general goals (page 7) focus on one topic area only, i.e., are not synergistic in terms of combining together the specific section goals. The Commission also discussed whether 26 objectives are too many in the Front Porch Community Planning & Design draft natural resources section. The commission decided that the goals provide the general vision or statement for each section (i.e., provide the seeds for the objectives in each section). The objectives will be evaluated as to whether they link adequately to the goals and each objective must support one or more goal. The Planning Commission will continue the discussion during its next meeting.
