12	Consider Zoning Change Requests
13	- Gateway Commercial Zoning District (Reap request) – Joy Reap requested to
14	table the agenda item.
15	Parke made a motion to table the agenda item, seconded by Tellstone. All in
16	favor, so voted. Reap abstained.
17	 Commercial Zoning District (Donovan request) – Bill Donovan reiterated his
18	zoning change request to allow for residential uses to be allowed in the
19	Commercial Zoning District as he would like to add four apartments above the
20	Lucky Spot Convenience Store. Discussion followed regarding the email
21	interpretation provided by VLCT, which indicates that residential uses may be
22	allowed in the district due the language in the Purpose statement of the
23	Commercial District. Discussion followed about how more than one principal use
24	could be allowed due to another provision in the regulations. Discussion
25	followed about the possibility to seek approval for the residential uses as a PUD.
26	The PC determined that no action was needed by the PC and the PC suggests
27	Donovan consider submitting an application to the DRB for the desired uses.
28 29	Discussion followed shout whether the DC would or should take on small/minor
29 30	Discussion followed about whether the PC would or should take on small/minor zoning changes as the town plan is underway or whether they should wait to do
30 31	one comprehensive change once the town plan is completed.

33	- Review Introduction Chapter to new Town Plan – PC reviewed the new draft
33 34	section. Comments included: making the Process section shorter, and additional
35	comments Rock shall incorporate in to the next draft. (see notes on draft dated
36	June 13, 2016)
37	Tellstone requested a list of the State town plan requirements. Other PC members
38	requested a link to the Essex Junction Town Plan as this was referenced at an
39	RPC event. PC members also requested copies of draft sections as word
40	documents so they could use track changes for edits.

42	- Future Land Use Map – Rock briefly went over the draft alternative future land
43	use maps. July 4 th would be an opportunity to share with the public. The PC
44	would like more information and time to review the maps. The PC agreed to
45	meet for this purpose on Tuesday June 21 at 5:30pm.
