13 **Public comment**

14 Alison Anand announced she was at the PC meeting as a liaison for the Conservation Commission.

16 **Town Plan Data Presentation**

17 Rebecca Sanborn Stone, Community Workshop LLC, presented updated Census and Economic data  
18 for the Town of Richmond for the new town plan. Data presented included demographics, housing  
19 and economic data.

21 LaBounty questioned whether there is data about commercial businesses, such as number of  
22 employees. Reap suggested posting the data along with the local tax rate. Discussion followed about  
23 the tax rate and comparisons to other towns. Stone will make the link to the presentation available  
24 so the Town may upload it to the municipal web site and to the Our Town, Our Future website.

26 Discussion included the lack of young people in Richmond and the lack of apartments. PC members  
27 questioned how do we reach out to this demographic to ask them what they want for the future of  
28 Richmond? Fausel suggested providing the survey or interview questions to a high school teacher  
29 so they may gather input from students. Fausel will follow up with the social studies teacher.

31 Cochran's Ski Area was mentioned as a possible venue for the fall Vision Forum.

47 meeting. Technical zoning changes will also be added to the next agenda and the latest list will be  
48 distributed in the PC packets.
