- March 15, 2017@ 21:01 hours, Sergeant Mat Nadeau assisted the Vermont State Police on the Bolton Access Road as there were approximately 10 vehicles off the roadway due to road conditions.
- March 17, 2017@ 20:13 hours, Officer John Hamlin responded to a single vehicle accident on Governor Peck Road in Richmond. While investigating the accident he determined that the operator was under the influence of alcohol. A nearby Trooper who was training a new Trooper requested that they be allowed to have the trainee Trooper process the DUI as he had not been able to do so. John handled the accident and the new Trooper handled the DUI under one of their case numbers.
- March 19, 2017@ 11:58 hours, Cpl. Rick Greenough responded to the same residence on East Street in Bolton to assist the Vermont State Police. In the first call Troopers were advised of a male walking up to doors looking for help getting his vehicle out of a ditch. Cpl. Greenough located the male who appeared that he was under the influence of alcohol. He was taken into custody by VSP and transported back to the barracks to be processed. Short time later officers were dispatched to the same home for a family fight involving the same male who had been picked up by his mother after being processed and got into a fight with his girlfriend. Sometime during the event the girlfriend slipped in the snow and appeared to have broken an ankle unrelated to the fight so Richmond Rescue was summoned. When things cooled down Cpl. Greenough cleared from the scene as Troopers continued their investigation.
- March 19, 2017@ 17:13 hours, Sergeant Mat Nadeau was dispatched to a vehicle off the road on West Main Street near Cochran Road. After arriving at the scene Mat located the 26 year old male operator and his passenger. The operator appeared to be under the influence of alcohol and was screened roadside which included a roadside breath test which registered a BAC of .185%. He was taken into custody and transported to the barracks at the request of the Troopers so a new Trooper could witness the processing. The operator blew a BAC of .156% on the evidentiary test and was cited into court and released to his mother.
- March 21, 2017@ 11:24 hours, Cpl. Rick Greenough responded to a family fight at a Lower Circle home involving an adult male and female. The male had fled the scene prior to Rick's arrival and after punching some holes in a door. The home owners were uncooperative and not happy that law enforcement was there. Cpl. Greenough gave them multiple options and left statement forms if they changed their minds about seeking court action.
- March 25, 2017@ 08:45 hours, Cpl. William Bullock responded to a family fight/theft complaint at a Kenyon Road home that we have responded to on numerous occasions. The fight was verbal and involved the theft of money from a purse that the female victim could not verify that the male ex-boyfriend had actually taken. Currently there were no active court conditions on the male suspect who we have arrested many times and no probable cause to charge with a theft. The victim decided to go to family court and get another restraining order.
- March 26, 2017@ 02:01 hours, Sergeant Mat Nadeau observed a vehicle pass him on Route 117 that South Burlington P.D. had put out a BOL on for erratic operation. The vehicle got on the Interstate at Exit 11 and Sgt. Nadeau stopped it a short time later. All occupants were identified as 19 years old. Alcohol could be smelled which was determined was coming from the male

passenger who registered a roadside BAC of .161%. The female operator was determined had not consumed alcohol. A consent search was granted and Sgt. Nadeau located a small amount of marijuana, bong, grinder and a half full bottle of Vodka. The parties were later released but issued court diversion paperwork for possession and consumption of alcohol as well as possession of marijuana.

March 28, 2017@ 00:28 hours, Sergeant Nadeau was monitoring traffic near exit 11 when he
observed a vehicle travelling a 108 miles per hour. A traffic stop was conducted and the vehicle
was being operated by a female who resides in Colchester. She was taken into custody and
processed at the office before being released on a citation charged with Careless & Negligent
operation of a vehicle.
