- 11/08/2017: Cpl. Bullock completed an investigation into possible fraud being committed
 against a local business. It was determined that the perpetrator, who was identified as a former
 employee of the business, had fraudulently represented himself as a current employee in order
 to obtain funds from local auto parts stores. He was subsequently charged with False Tokens
 and False Personation.
- 11/09/2017: Cpl. Bullock conducted Sex Offender Registry checks on individuals living in the community. Contact was made with all parties who were determined to be in compliance.
- 11/10/2017: Cpl. Bullock began an investigation in to possible home improvement fraud based on a referral by the Vermont Attorney General's Office. The investigation which is ongoing involves victims in both Vermont and New York State.
- 11/10/2017: Cpl. Bullock conducted a ride along.
- 11/10/2017: Cpl. Hamlin assisted Williston Police Department with an investigation into an individual who had robbed the Taft Corners Mobil at gunpoint. Williston Police Department is continuing to investigate the incident.
- 11/13/2017: I conducted a traffic stop on a vehicle on Route 117 for defective equipment. The female operator was determined to have a civilly suspended operator's license. An open alcoholic container was also located in the vehicle. Consent was ultimately granted to search the vehicle. During the search I located a small amount of marijuana, 2 grinders, 2 glass blown pipes with residue, a copper scrubbing pad, several empty torn off plastic baggie corners and a plastic bottle containing several prescription pills. The female passenger confirmed my suspicion that she was a crack cocaine user. The operator was issued a VCVC for Operating with a Suspended License (Civil) and the passenger was issued a VCVC for Possession of Marijuana. The vehicle subsequently grounded. The passenger was given an opportunity to appear at Richmond Pol I attempted to locate her at her stated residence in Essex. I was ultimately unable to locate her and submitted a request to the court to issue a warrant for her arrest to answer to the charge of Possession of Narcotics.
- 11/15/2017: I observed an occupied vehicle parked behind the law offices at the corner of
 Jericho Road and East Main Street. Upon making contact with the parties I determined the male
 occupant had been consuming alcohol and was under 21 years of age. He provided a breath
 sample of 0.093%. He was issued court diversion paperwork. The vehicle was secured in the
 parking lot and the parties were released to return to their nearby residence on West Main
 Street.
- 11/16/2017: Over the past 4 months a female applicant had been going through the hiring process for a position in Richmond Police Department. She was unable to pass the polygraph phase of the hiring process and is no longer being considered for the position. She has been deferred from applying again for 3 years.

- 11/17/2017: I conducted a traffic stop on a vehicle traveling north bound on Interstate 89 that
 was failing to maintain its lane. While speaking with the male operator and female passenger I
 detected an odor of marijuana coming from the interior of the vehicle. Consent was granted to
 search. I located approximately 6 grams of marijuana and a glass blown pipe with residue. The
 male operator was issued a VCVC for Possession of Marijuana (Civil). The parties were
 subsequently released.
- 11/18/2017: I conducted a traffic stop on a vehicle on Governor Peck Road for defective equipment. The male operator was determined to have a criminally suspended operator's license. After taking him into custody I conducted a search of his person incident to his arrest at which time I located a small amount of marijuana and a package containing a partial Suboxone strip. Additionally it was determined that the male was in violation of 2 separate conditions of release which prohibits him from operating a vehicle without a valid operator's license. The male was processed at Richmond Police Department. He was issued a citation for Operating with a Suspended License (Criminal), Possession of Narcotics and Violation of Conditions of Release x 2. He was additionally issued VCVCs for Possession of Marijuana (Civil), Operating without Liability Insurance and Defective Equipment. At the completion of processing he was provided with a courtesy ride back to his residence.
- 11/20/2017: Cpl. Lindemuth conducted a traffic stop on a vehicle on East Main Street for speeding. The female operator surrendered a small amount of marijuana and a glass blown pipe. She was issued VCVCs for Speeding and Possession of Marijuana (Civil).
- 11/21/2017: Cpl. Hamlin assisted Williston Police Department with setting up a perimeter after a business on Avenue D had been broken into. It was determined that the perpetrators had stolen cash from the business then fled the area. Williston Police Department continues to investigate the incident.
