## **TOTAL INCIDENTS REPORTED: 52**

- July 14, 2015@ 17:48 hours, Officer Mat Nadeau was dispatched to an accident located on Main Road in Huntington. At the time of this collision the two Troopers on-duty were tied up with two accidents on the Interstate. Officer Nadeau arrived at the scene of this single vehicle accident. During the course of his investigation he developed probable cause to believe that the male operator was under the influence of alcohol. The operator was put through roadside dexterity tests, but refused the roadside breath test. He was taken into custody and transported to the office for processing. An evidentiary breath test was administered which registered a BAC of .181%. A consent search of the vehicle resulted in the discovery of a small amount of marijuana and a glass pipe. The operator was cited into Chittenden Superior Court to answer a charge of DUI as well as issued a civil ticket for possession of less than 1 oz. of marijuana.
- July 18, 2015@ 18:20 hours, Officer Mat Nadeau stopped a vehicle on East Main Street for travelling 46 in a posted 30 mile per hour zone. As he approached the vehicle he detected an odor of marijuana coming from the vehicle and/or the two occupants. After speaking with the operator consent search was given which resulted in the recovery of 2 burnt marijuana cigarettes and 2 sandwich bags with a large quantity of green leafy material which later tested positive for marijuana. The operator was issued a speeding and possession of marijuana ticket and the passenger was issued a possession of marijuana ticket.
- July 20, 2015@ 14:06 hours, Cpl. Rick Greenough and his trainee, Officer John Hamlin were dispatched to a two vehicle accident at the culvert construction site located on Huntington Road by the Farr farm. Once on scene of the minor collision it was determined that the female operator of one vehicle rear ended a vehicle stopped for the temporary traffic signal. Investigation also found probable cause to believe that the female operator was currently under the influence of alcohol. A roadside breath test resulted in a BAC of .105% after which she was transported back to the office for processing. This was the operator 2<sup>nd</sup> DUI arrests and she stretched the process out as long as she could but eventually she submitted to n evidentiary breath test which registered a BAC of .085%. She was cited into Chittenden Superior Court to answer a charge of DUI#2 as well as being issued a single traffic ticket.
- July 22, 2015@ 17:11 hours, Officer Brett Lindemuth responded to a theft complaint from a parked vehicle at the gorge on Dugway Road. The victim had left a backpack inside the car. A hammer was used to smash a window and the backpack was stolen which contained a \$3,000 Mac book Pro computer owned by his employer.
- July 23, 2015@ 12:46 hours, I assisted the Vermont State Police with traffic on Interstate 89(N) at exit 11. One half of a modular home was entering the interstate from exit 11 when the home slid off the trailer blocking parts of both the merge lane and right travel lane. Traffic control was needed until the company was able to jack the home back onto the trailer at which point it was

- escorted to the Williston rest area and turned over to the Department of Motor Vehicles commercial truck inspection team.
- July 23, 2015@ 12:32 hours, Officer John Hamlin and Cpl. Rick Greenough responded to a theft complaint on Valley View Extension. Sometime over night a friend of the family's son had his unlocked car gone through and a wallet with approximately \$120.00 in cash in it was stolen.
- July 23, 2015@ 18:34 hours, Officer Brett Lindemuth responded to a home on Orchard Terrace.
   Sometime during the day the home owners had left but when they returned they found the front door wide open and the dog on front porch. When they left the garage was unlocked but the front door was secured. A search of the home by the owners did not discover anything missing.
- July 25, 2015@ 21:09 hours, Officer Mat Nadeau responded to assist the Vermont State Police
  with a single vehicle accident on Stage Road in Bolton. Once on scene the operator was not
  located but was located approximately 1.5 miles from the scene at a home. Investigation
  determined that the female operator was under the influence of alcohol and was arrested by
  the Trooper.
- July 27, 2015@ 17:09 hours, Officer Mat Nadeau stopped a vehicle on Cochran Road for speeding. The male operator was currently criminally suspended in the State of Vermont, did not have insurance on the vehicle nor was it registered. He was taken into custody and processed for DLS-C as well as being ticketed for speed, no insurance and no registration, as the plated on the vehicle did not belong to him. The plates were seized and the vehicle towed. The operator was ordered into Chittenden Superior Court to answer a charge of operating while criminally suspended.
