- July 23, 2013@07:54 hours. Officer Lance Martel was called to Tilden Ave. for a Trespass complaint. A 44 year old male we have been dealing with was inside his parent's garage after being served with a trespass notice. Subject was again charged and cited into court.
- July 23, 2013@ 09:37 hours Officer Lance Martel handled a complaint from the manager of a local business. The manager had been called dozens of times within a one hour time frame and sent text messages with photos of a gun and numerous threats of his head being cut off and being killed. Working with the Lamoille County Sheriff's office who knew the suspect well, he was located in Johnson and cited into court to answer a charge of D.C. by phone.
- July 24, 2013@ 12:53 hours. Officer Martel was again called to Tilden Ave. for a trespass complaint on the same 44 year old male. He was again charged with trespass and cited into court.
- July 25, 2013@ 23:54 hours Officer Joshua Hansell stopped a motor vehicle for a traffic violation. The female operator blew a BAC of .08% roadside and was transported back to the office to be processed for DUI.
- July 28, 2013, evening Cpl. Jake Hansell & Officer Lance Martel were requested to back up a trooper in Underhill with agitated male who had a hand gun and was threatening to kill another man. The very intoxicated male (.203% BAC) was successfully taken into custody. We transported the hostile male to the jail as we had a cruiser with a cage where he was charged with burglary to be arraigned the next day.

- July 28, 2013, evening. Cpl Jake Hansell and Officer Martel dealt with our Tilden Ave. trespasser again. He was arrested and lodged at the regional correctional center.
- July 29, 2013@ 14:39 hours, Officer Brett Lindemuth observed our Tilden Ave suspect who appeared intoxicated which is a violation of his release conditions. A PBT resulted in a BAC of .163%. He was charged with Violating Court Conditions of Release and returned to jail.
- August 5, 2013@ 07:35 hours, Officer Brett Lindemuth was watching traffic at the 4 corners in town. The police department had information from both Williston & Hinesburg police that a male who was criminally suspended would be operating a vehicle and liked to stop at the Cumberland Farms store in the morning while transporting one or more pre teen children. Officer Lindemuth spotted the vehicle with the male as described and made traffic stop. The male initially lied about who he was but was later identified. He was charged with operating a motor vehicle while criminally suspended and false information to a police officer. He was cited to appear in court at a later date and a family member came to pick him and his young son up after processing.
- July 31, 2013. Sometime during the evening the police department's speed cart was located on Cemetery Road. Someone vandalized the unit and attempted to push it over and damage the speed display window. Rod West (Blackfork) picked the unit up and was able to repair it after a couple of days.
- August 2, 2013@ 07:30 hours, Officer Rick Greenough investigated a theft complaint from Southworth Cat. Sometime over the evening 2 catalytic converters had been cut out of two large vehicles. The converters are valued in excess of \$2,000 each.
- August 9, 2013@ 11:30 hours. Officer Rick Greenough took an initial complaint of sexual assault from a 15 year old victim and her grandmother. The victim was a former student under Officer Greenough while serving as the SRO at Camel's Hump Middle School. Officer Greenough had worked with the victim in the past while she attended the middle school for several years so she felt comfortable speaking to him about this incident. It seems she has been repeatedly sexually assaulted by an adult male friend of a family member since she was twelve years old. Officer Greenough obtained a full victim statement and then contacted CUSI. Based on the information obtained by Officer Greenough the case was transferred to CUSI for further investigation.

- August 10, 2013@ 19:54 hours, Cpl. Jake Hansell investigated a motor vehicle collision on Hinesburg Road with injury to the passenger. The male operator was taken into custody for DUI#3 which is a felony. The suspect blew a BAC of .128%. After processing the operator was lodged at the regional correctional center.
- August 11, 2013@ 19:56 hours, Cpl. Jake Hansell is called to an apartment at 51 West Main Street for a family fight. During the course of his investigation a female was taken into custody for domestic assault. She was brought back to the office for processing where she was flash cited to appear in Chittenden Court for the next Tuesday to answer a charge of domestic assault.
- August 12, 2013@ 15:04 hours, Officer Brett Lindemuth spotted a vehicle on Huntington Road (S) travelling at 67 miles per hour in the 45 zone. When he attempted to stop it the vehicle

refused to stop and reached speeds in excess of 80 miles per hour into Huntington. The operator of the vehicle finally gave up the chase in Huntington. The male was charged with attempting to elude, careless & negligent operation and cited into Chittenden Court to answer these charges. He was also issued a civil ticket for a person under 21 in possession of less than 1 oz. of marijuana.

- August 12, 2013@ 00:36 hours, Officer Brett Lindemuth was called to a family disturbance on Christmas Hill Road. The male party in the disturbance was intoxicated and registered a BAC of .168%. He was taken to ACT 1 to be held until sober.
- Important Notes: On August 5<sup>th</sup>, Officer Lance Martel started his 16 week training at the Police Academy. On August 9<sup>th</sup>, Officer Jacob Hansell was promoted to the rank of Corporal and on August 10<sup>th</sup>, Officer Joshua Hansell completed his last shift as a full time member of the Richmond Police Department. Josh will be serving the town of Williston as a full time member of their police department but will remain a part time member here.
