- August 13, 2013@ 00:03 hours Officer Lindemuth was dispatched to a family fight, non physical.
   The male party was administered a PBT which registered a BAC of .168%. He was transported to ACT 1 in Burlington to be released when sober.
- August 14, 2013@ 17:03 hours, Officer Lindermuth recognized a driver who was criminally suspended. A traffic stop was conducted on Cochran Road and the male was cited into court to answer a charge of operating a motor vehicle while suspended.
- August 16, 2013@ 03:30 hours Officer Bullock investigated the theft of a scale from the veggie stand located on Huntington Road.
- August 16, 2013@ 11:40 hours, Officer Greenough made a traffic stop on Gov. Peck Road. The
  male operator initially gave a false identification but Officer Greenough felt things did not add
  up. After further investigation the operator admitted who he was and lied because he did not
  want to go back to jail. After confirming his identity it was discovered that there was a warrant
  for his arrest and that his right to operate a motor vehicle was criminally suspended. He was
  charged with DLS-criminal, false information to a police officer and lodged on the warrant which
  mandated \$750.00 cash bail.
- August 16, 2013@ 21:28 hours, Cpl. Hansell assisted the Williston Police department with a
  motor vehicle collision. A female Richmond resident was taken into custody for DUI after
  blowing into a PBT which registered a BAC of .140%. Cpl. Hansell provided a supporting affidavit
  to the Williston officer.
- August 19, 2013@ 14:44 hours, Officer Lindemuth investigated a larceny from a motor vehicle parked at the Lower Gorge. The rear passenger window was smashed to gain access to the three wallets left in plain view inside the vehicle. The 4 teenagers from Essex lost approximately \$30.00 in cash.

- August 26, 2013@ 12:47 hours, Officer Greenough was dispatched to the intersection of Main & Bridge Street for a reported suspicious bottle leaning up against a power pole. The plastic Coke bottle contained only water.
- The 4<sup>th</sup> of July celebration went off on August 24<sup>th</sup>. Most hands were on duty all day and night. There were no significant complaints generated and all traffic was directed out of the fireworks site by 22:20 hours. I would estimate that 300-400 people walked down Bridge Street to attend the fireworks.
