- May 26, 2015, Officer Mat Nadeau as a case follow up has identified a couple of juvenile suspects in a small arson fire that occurred a few day earlier at an apartment on East Main Street. The investigation is ongoing with interviews with the parents being lined up.
- May 28, 2015@ 17:05 hours, Officer Brett Lindemuth was watching traffic on West Main Street
 when he observed a vehicle pass him with a male he recognized s being under criminal
 suspension. A traffic stop was conducted and the operator was taken into custody for criminal
 operation of a motor vehicle. He was released on a citation ordering him into Chittenden
 Superior Court.
- May 29, 2015, as a continuing investigation of a burglary that occurred in November 2014 from a home on Hinesburg Road, we obtained a CD of stolen property recovered in a search warrant conducted by Stowe Police. Officer Brett Lindemuth was able to have one of his victims review the over 700 pieces of jewelry recovered and she was able to identify 61 pieces that had been stolen from her home. The 40 year old male suspect had been arrested and lodged by us for another burglary happening on Hinesburg Road near that time and had since been arrested by other agencies for numerous other burglaries in surrounding areas. The suspect is currently lodged in jail and will be charged with an additional burglary. We are still working with several other victims in an attempt to see if they can identify any of the recovered items.
- May 29, 2015@ 08:09 hours, Cpl. William Bullock responded to a residence on Railroad Street.
 Sometime overnight two vehicles had a total of three tires damaged when they were slashed with a sharp object, probably a knife.
- June 1, 2015, we completed a Governor's Highway Traffic Safety initiative that required we complete at least 28 hours of traffic patrol time. This program ran from May 18th- June 1st. We compiled 43 hours that resulted in 31 traffic tickets and 2 arrests. Completing the project now will make us eligible for a grant for up to \$1,500 in new equipment.
- June 4, 2015 starting at 15:28 hours, Officer Brett Lindemuth responded to a Kenyon Road home twice for a reported family disturbance. There was no criminal evidence as the alleged victim would not give a statement and no physical evidence was obtained. The home owner was given the information on what the proper procedure were. At 20:35 hours, Officer Lindemuth was again responding to the area when he encountered the suspect's vehicle off the road in a ditch. The operator was located a short time later as he had fled the scene on foot headed back to the Kenyon Road home. Sighs of alcohol impairment were observed a roadside breath test registered a BAC of .087. He was taken into custody and processed for DUI and the paperwork will be submitted to the court.
- June 5, 2015@ 12:01 hours, Cpl. William Bullock again responded to the Kenyon Road home for a citizen dispute. It seems the home owner is attempting to provoke an issue when there is no criminal event. Again she was explained that proper route she must take through family court to help resolve the issue as the alleged victim will not provide a statement of any kind.
- June 6, 2015@ 10:27 hours, Cpl. William Bullock responded to a theft complaint on West Main Street. Some time overnight 4 tires on the deck of the home were stolen. The tire was for a

- Subaru Impreza. On 060415, Cpl. Bullock had a similar tire theft for tires that fit a Subaru Impreza. These investigations are ongoing.
- June 7, 2015@ 22:19 hours, Officer Mat Nadeau conducted a traffic stop on East Main Street for defective equipment. A computer check revealed the operator was currently criminally suspended for a long list of prior traffic infractions. He was taken into custody, processed and released on a citation to his girlfriend ordering him into Chittenden Superior Court.
