- On March 28, 2013 Officer Rick Greenough as part of his S.R.O. duties at the school had to appear at Vermont Superior Court for 2 truancy hearings for students that attend Camel's Hump Middle School.
- April 4, 2013 at approximately 07:30 Officers William Bullock, Rick Greenough and myself
 responded to Browns Court for a family fight involving a male and two women. The investigation
 resulted in the male being taken into custody by Officer Bullock. He was charged with one count
 each of criminally operating a motor vehicle, unlawful mischief for punching holes through the
 walls of the rental property and cultivation of marijuana as he had 8 sets of immature marijuana
 plants growing in his bedroom.
- April 6, 2013 at approximately 2330 hours Officer Brett Lindemuth was conducted a directed patrol near the area of Fays Corners as a result of the laser incident involving a pilot of a commercial airline the prior night. Assisting in the patrol where the Vermont State Police, Williston Police and a Vermont Game Warden. A traffic stop resulted in 4 people all under the age of 21 being issued TASP tickets by Officer Lindemuth for possession/consuming alcohol. The 2 female and 2 males all blew alcohol numbers with one 18 year old Richmond male blowing a

.15% BAC. A loaded 12 gauge shotgun was discovered in the vehicle which Vermont Warden Tom Cook took possession of charging a $5^{\rm th}$ person with the loaded weapons charge.
