- 12/20/2017: Cpl. Hamlin participated in a DUI check point hosted by Vermont State Police on Route 2A in the town of St. George. Several Chittenden County agencies sent officers to man the check point.
- 12/21/2017: Cpl. Hamlin and Cpl. Bullock spent several hours conducting traffic control on West Main Street, Route 117 and Governor Peck Road while Richmond Fire Department fought a structure fire at a residence on Governor Peck.
- 12/22/2017: Cpl. Hamlin assisted Vermont State Police with several slide offs and disabled vehicles on Interstate 89 due to the inclement weather.
- 12/23/2017: Cpl. Bullock and Cpl. Lindemuth continued dealing with several slide offs and disabled vehicles in the area due to inclement weather.
- 12/24/2017: Cpl. Greenough brought a much deserved Christmas to a struggling family in town on Christmas Eve. Cpl. Greenough rallied the assistance of Richmond Fire Department's Toys for Tots program as well as several area businesses and was able to gather donations including toys, a new bicycle and groceries which were delivered to the family. Well done Cpl. Greenough.
- 12/28/2017: Cpl. Hamlin assisted emergency crews responding to a chimney fire at a multi-unit residence on Village Lane in Bolton. Cpl. Hamlin provided traffic control while area fire departments battle the fire.
- 12/29/2017: Cpl. Bullock and Cpl. Hamlin responded to a report of a family fight in progress at a residence on Governor Peck Road. Officers determined it to be a verbal altercation over the residence being in complete disrepair. Due to observations of the condition of the residence and confirmation that the parties were living in those conditions with an 11 year old juvenile, the Town Health Officer and the Department of Children and Families were notified.
- 12/29/2017: Cpl. Hamlin responded to Lower Circle for a report of a family fight in progress. Cpl. Hamlin determined it to be a verbal altercation over a custodial dispute. An agreement was reached and the parties separated for the evening.
- 01/01/2018: Cpl. Bullock received a report of a 13 foot metal sculpture that was stolen from the intersection of Huntington Road and Hinesburg Road overnight. Cpl. Bullock enlisted the assistance of local media outlets to get word out about the theft and to request information which could identify the perpetrators and recover the property. On the morning of 01/03/2018 Cpl. Bullock received a report that the sculpture had been left on the roadside on Hinesburg Road a short distance from where it had originally been taken. The sculpture was returned to its owners at SLAG Sculptures.
- 01/03/2017: Cpl. Hamlin and I responded to a residence on Lower Circle for a report of a female who was highly intoxicated and out of control making suicidal statements. The complainant who was the mother of the female requested her daughter be removed from the residence for the night. Cpl. Hamlin and I made contact with the female at the residence who was not compliant at any point during our interaction. An investigation revealed that she was in violation of active court conditions which prohibited her from consuming alcohol. She was taken into custody and transported to Richmond Police Department. While attempting processing, the female assaulted me and attempted to assault Cpl. Hamlin and an assisting Trooper on scene. The female ultimately had to be transported to the University of Vermont Medical Center due to her high

level of intoxication and statements of self-harm. The female continued to be combative with us as well as Richmond Rescue personnel and ultimately had to be sedated in order to be transported. The female was issued a citation to appear at Chittenden Superior Court at a later date to answer to the charges of Violation of Conditions of Release and Assault on a Law Enforcement Officer. She was subsequently released into the custody of University of Vermont Medical Center personnel who intended to hold her until she was sober and could undergo a mental health evaluation.
