- 1- December 14, 2016@ 22:23 hours, Cpl. Rick Greenough responded to the area of Skunk Hollow Road in Jericho for an injury accident. When he arrived a passing doctor was performing CPR on the 22 year old operator and lone occupant. Rick grabbed his A.E.D. and attached it to the victim, however this was unsuccessful. The young operator after crashing his vehicle had shot himself in the head with a handgun. It is believed that it was the same vehicle Rick attempted to stop for speeding a few minutes earlier near the Lucky Spot store but he never caught up to the vehicle because of its speed. Vermont State Police uniform and detectives are handling the investigation.
- 2- Cpl. Rick Greenough assisted the Vermont State Police by responding to mile marker 77 on the Interstate to put a deer down that had been struck by a vehicle.
- 3- Cpl. William Bullock responded to Duxbury Road in Bolton a short distance over the town line for an activated burglary alarm. When he arrived the front door was found open and a dog standing in doorway. The home was cleared and the home owner arrived just as the check was finishing. Turned out to be a false alarm.
- 4&5- December 17, 2016 was a slippery winter day for all area law enforcement agencies in the area. At 11:10 hours, Officer John Hamlin handled a two vehicle traffic accident on Interstate 89(S) on French Hill for the State Police as they were tied up with numerous other accidents and vehicles off the road. At 12:19 John responded to an area just north of Richmond Flats on the Interstate to assist a Trooper out at another accident on a curve in a bad location. He assisted with blue lights and by placing flares out until a tow truck could respond and remove the vehicle.
- 6- December 19, 2016@ 13:40 hours, myself and Cpl. Rick Greenough assisted highway after one of their plow trucks slid off of Kenyon Road blocking both lanes. Highway was able to successfully pull the truck back onto the road after dumping more sand and using a second truck to pull. The road was extremely slick from ice at the time.
- 7- December 19, 2016@ 16:49 hours, Officer Mat Nadeau assisted a Trooper with a vehicle search occupied by 4 college aged students by exit 11. The search by the Trooper turned up some marijuana and paraphernalia along with an unlabeled pill bottle with multiple pills. The case is ongoing by VSP at this time.
- 8- December 22, 2016@ 19:03 hours the Vermont State Police were dispatched to the area of exit 11 for a vehicle in the road where two people were seen running from the vehicle. Officer John Hamlin searched the area around exit 11 to include the trailer park where the registered owner resides. Turns out the vehicle broke down and the operator was currently suspended who John located. He turned over the information to VSP for further investigation.
- 9- December 23, 2016@ 06:27 hours, Cpl. Bill Bullock responded to the area of mile marker 77 for a reported traffic hazard in the south lane. Hazard was gone when he arrived a short time later.

10- December 26, 2016@ 15:14 hours, Cpl. Rick Greenough along with Constable Andy Squires responded to a Jericho home for an activated burglary alarm to assist the State Police. The home was checked and found to be secure and the owner was contacted by phone.

- December 17, 2016 during the snowy day, Cpl. Bill Bullock responded to 4 separate motor vehicle calls for vehicles that slid off the road.
- December 19, 2016@ 15:28 hours, Cpl. Rick Greenough and Constable Squires responded to a
  theft complaint of a small amount of cash from a River Road business. There was no sign of
  forced entry and the case is active at this time.
- December 19, 2016@ 18:01 hours, Officer Mat Nadeau began a drug investigation after a repossessed vehicle was found to contain over a 100 empty heroin baggies. Investigation is continuing.
- December 22, 2016@ 08:24 hours, Cpl. Bill Bullock responded to a larceny complaint from a home construction site located off Huntington Road. A construction trailer was broken into and numerous tools were taken sometime overnight. This is the second break at this site in the last 4-6 weeks.
- December 23, 2016@ 21:58 hours, Officer John Hamlin was on patrol on Kenyon Road when he observed a male thumbing a ride and holding a beer. The Richmond Police Department has dealt with this male many times in the recent past and a check of his current court conditions showed that he was prohibited from possessing, consuming or buying alcohol. The 28 year old male was taken into custody after blowing a BAC of .069% where he was processed and cited into court. Williston Police had a new trainee officer and requested that the processing take place at their office so the trainee could observe which was done.
- December 24, 2016@ 11:17 hours, Cpl. Bill Bullock and an Officer from Williston Police responded to Patterson's Fuels for a reported burglary in progress by a person wearing a ski mask and hooded sweatshirt. Shortly after police arrived the suspect exited the building matching the description. Seems the burglary was at the location to service their trucks but also entered the building where he got into a cash box and rifled through desks. The suspect was taken into custody and Officer John Hamlin was called in early to assist in searching the vehicle while Cpl. Bullock prepared the paperwork to lodge the suspect at the county correctional center.
