- October 27, 2016@ 05:37 hours, I assisted the Vermont State Police and Richmond rescue on Milo White Road in Jericho with a 63 year old bi-polar male having a mental episode. Rescue staged down the road while arrived first and was able to secure the scene. Rescue and a Trooper responded and the male was transported to the emergency room for an evaluation.
- October 27, 2016@ 07:10 hours, Cpl. Brett Lindemuth came upon a vehicle vs. pedestrian accident on East Street in Huntington. Richmond Rescue and Troopers from the Vermont State Police responded to the scene. Injuries were minor.
- October 27, 2016@ 08: 45 Cpl. Brett Lindemuth assisted the Camel's Hump Middle School Assistant Principle with a report of sexual contact between an 8th grade male student and 6th grade female student. The case was transferred to CUSI for review.
- October 27, 2016@ 21:02 hours, Officer Mat Nadeau assisted the Vermont State Police on the Bolton Access Road after a snow fall that sent approximately 8 vehicles off the roadway. No major damage and no injuries.
- October 28, 2016@ 21:27 hours, Officer Mat Nadeau assisted the Vermont State Police with an ongoing domestic assault at a home located on Route 2 in Bolton. A 19 year old intoxicated male was transported from the scene by VSP.
- October 30, 2016@ 07:55 hours, Cpl. Rick Greenough assisted the Vermont State Police with an accident on Interstate 89 by exit 11. Cpl. Greenough screened the 17 year old male for possible DUI and he blew a roadside test of .057%. Cpl. Greenough issued the operator a traffic ticket for having a BAC above .02% by a person under 21.

- October 31, 2016@ 10:26 hours, I was dispatched to the trailer park to assist Richmond Rescue with a lift. Rescue was able to get the 71 year old female over the porch railing just as I arrived.
- November 2, 2016@ 04:48 hours I was dispatched to an accident on Interstate 89(S) at the Richmond/Bolton town line for a car vs. deer accident. I handled the accident as no trooper was scheduled to sign on for a couple of hours.
- November 5, 2016@ 23:05 hours, Officer John Hamlin was requested to check on a car in the median near mile marker 76 (Richmond Flats). At initial call there were no Troopers in the area. Officer Hamlin located the vehicle which had struck a deer. A tow service was requested and Officer Hamlin stood by until a Trooper arrived on scene.
- November 7, 2016@ 12:39 hours I assisted the courts by serving paperwork on a local attorney on behalf of a juvenile.
- November 11, 2016@ 16:00 hours, Cpl. William Bullock and Officer John Hamlin responded to the Richmond Park & Ride with Richmond Rescue for a reported male seizing. The male was having a medical seizure and was assisted onto a stretcher from a company van by the officers and rescue. He was transported to the emergency room.
- November 11, 2016@ 19:16 hours, Officer John Hamlin, Richmond Rescue and a Trooper were dispatched to a Stage Road home in Bolton for a reported drug overdose. A 14 year old male had attempted to commit suicide by overdosing on prescription pills belonging to a family member. The juvenile was not cooperate and was transported to the emergency room by Officer Hamlin who had a cruiser equipped with a prisoner transport cage.
- November 14, 2016@ 19:19 hours, Officer Mat Nadeau assisted the Vermont State Police with a welfare check in Jericho that was having mental health issues. Troopers arrived on scene and the juvenile male was transported to the emergency room for an evaluation.

TOTAL INCIDENTS REPORTED: 65

- October 25, 2016@ 18:10 hours, Officer John Hamlin took a fraud complaint. The victim's credit card had been hacked and a total of \$671.92 had been charged to her account.
- October 28, 2016@ 09:15 hours I clocked a vehicle travelling on Cochran Road by the horse stables at 84 miles per hour in a 45 zone. The gentleman who Cpl. Bullock and I dealt with a few weeks earlier when we took a loaded rifle out of his truck was issued a traffic ticket in the amount of \$406.00.
- October 28, 2016@ 23>33 hours while on a traffic stop, Officer mat Nadeau was approached by a female who advised she had just witnessed a vehicle stop on Skunk Hollow Road in Jericho and steal Trump signs off the lawn. Officer Nadeau had dispatch put out a B.O.L. for the vehicle county wide which was not located at this time.
- October 29, 2016, Cpl. William Bullock as a follow-up on nuisance dogs issued the dog's owner a municipal ticket for the offense.

- October 30, 2016@ 16:27 hours, Officer John Hamlin was dispatched to 491 Wes White Hill Road for a reported rollover accident. The 16 year old male who was uninjured admitted to travelling between 50-55 miles per hour down the hill and was issued a traffic ticket for excessive speed with accident.
- October 31, 2016@ 13:57 hours, Cpl. Rick Greenough, myself and Richmond Rescue responded to the trailer park for a suicide attempt. A 15 year old hung herself in the bedroom and was discovered by the mother who got her down. The victim was transported to the emergency room for a metal health evaluation.
- November 4, 2016@ 12:39 hours the Vermont State Police put out a B.O.L. regarding a vehicle traveling toward Richmond from Jericho that was speeding and passing unsafely. The registration given did not come back. I took up a position at the town line on Gov. Peck Road and observed the vehicle pass my location. The vehicle was stopped near Summer Street and the 28 year old male was found to be operating while criminally suspended for a DUI and violating his court conditions of release. I took him into custody and processed him at the office where he was released on a citation ordering him into court.
- November 6, 2016@ 01:21 hours, Officer Mat Nadeau conducted a motor vehicle stop on Route 117 near the Lucky Spot Store. The 45 year old male claimed he had nothing to drink, however Officer Nadeau could smell the alcohol and took him into custody. An evidentiary breath sample at the office registered a BAC of .145%. He was cited into court and released to his wife.
- November 7, 2016@ 08:14, Cpl. Rick Greenough had two theft complaints come in. The first on Huntington Road involved the theft of a cell phone from an unlocked vehicle and the second was from Borden Street also from an unlocked vehicle in which an \$80 phone charger was stolen.
- November 7, 2016 we received a call from a police department in New Jersey. They had recovered an AR 15 style vehicle that was stolen from a home burglary in town back in 2014. They have sent the weapon along with a sawed shotgun that was recovered to their lab for a fingerprint/DNA examination.
- November 8, 2016@ 01:21 hours, Officer Mat Nadeau was headed home near exit 10 when he observed a vehicle travelling toward him that appeared to have been just involved in an accident. He stopped the vehicle on Route 100 in Waterbury and discovered the 31 year old male was under the influence of alcohol, was driving while criminally suspended and had been in the accident on I.S. 89(S) in Bolton where his front bumper with attached license plate was located. An evidentiary breath test registered a BAC of .181%. The operator was cited into court to answer the charges of DUI, Leaving the scene of an accident and Operating while criminally suspended.
- November 9, 2016, Cpl. William Bullock assisted the Erie County PA. Sheriff's Office with delivery a death notification message to a Richmond resident. Seems her 71 year old brother had passed away in their jurisdiction.

- November 10, 2016@ 14:21 hours, Cpl. William Bullock and I responded to the trailer park with a probation violation arrest warrant on a 40 year old male. We were able to locate the male in the park and Cpl. Bullock transported him to jail on the warrant.
