- August 30, 2016@ 15:25 hours, Cpl. Brett Lindemuth took a complaint of a threat to one of our local businesses. The threat was regarding an explosive device. The building was checked by staff and was secured. Because the threat was done over interstate lines the Federal Bureau of Alcohol, Tobacco & Firearms were notified.
- August 30, 2016@ 01:31 hours, Officer John Hamlin was requested to assist the Williston Police Department with some repeat home squatters. Seems these people find a home currently unoccupied and take of residence. They were issued trespass notices and will be charged if they repeat the offence again.
- September 1, 2016@ 22:17 hours, Officer John Hamlin was requested to respond to Hinesburg to back up the lone officer with a report of a fight involving at least 10 people. John responded along with two VSP units and one unit from Williston Police. Turns out to have been a verbal altercation that caller exaggerated when calling in. All parties attempted to flee when they heard sirens and the two principle people were located but were not forthcoming with information. Hinesburg Police to follow-up on case.
- September 2, 2016@ 07:31 hours, Cpl. William Bullock responded to a citizen dispute between two home owners in the Riverview Commons Park. This was at least the 5<sup>th</sup> time this year that we have responded to these types of complaints involving these two. I had spoken to the Chittenden County Reparative Board just recently concerning these two adults and they have agreed to take the case in an attempt to mediate some sort of truce.
- September 4, 2016@ 18:49 hours, Officer John Hamlin responded to a suspicious complaint at a home located off of Cochran Road. Prior to his arrival he was advised that the two young men had been picked up by a vehicle which John was able to locate and stop. The two men had been swimming and were stranded without a ride. They called for a cab but the cab did not show up so they contacted a friend. Their story checked out when interviewed by John.

- September 4, 2016 @ 22:37 hours, Officer Mat Nadeau was working a mandatory DUI check point in South Burlington as part of the Governor's Highway Safety Program. While at the check point he stopped a 25 year old female operator who appeared to be under the influence of alcohol. She was screened and processed for DUI where an evidentiary breath sample registered a BAC of .178%. After processing she was transported to ACT 1 in Burlington.
- September 7, 2016@ 10:54 hours, Cpl. William Bullock and I responded to the Mobil for a report of a male slumped behind the steering wheel. When we arrived both the male and female were identified and neither was unresponsive. While questioning the male it was determined that he was not being factual on his identity. When information did not add up both were confronted and both admitted he had been driving the vehicle. He initially provided a false date of birth because he was currently under suspension. When his correct identity was verified he was issued a traffic ticket for the offense.
- September 7, 2016@ 13:04 hours I was called to a suspicious complaint on Baker Street where gentlemen had been standing outside a resident's garage on a cell phone. When I arrived I was able to identify the male as a business owner whose crew was working on a house next door and he had been on his cell phone for almost three with Vermont Health Connect attempting to get coverage for his work crew. Standing outside at the house next door made it easier for him to hear the caller.
- September 9, 2016 Officer John Hamlin spent from 0700-1300 hours in court at a conference hearing on the aggravated domestic case he handled earlier this year. After being sequestered all morning it was decided his testimony would not be needed on this day.
- September 9, 2016@ 14:12 hours, Cpl. William Bullock and I responded to a domestic assault complaint at a Kenyon Road home. The investigation revealed that the male who was extremely intoxicated showed up at the home which he was barred from doing by court conditions. In his rage he ended up throwing several glasses, ashtrays and beer bottles at the female victim. He was taken into custody by us and charged with domestic assault, unlawful mischief and violation of court conditions. While we had him in custody he was also cited into court for additional charges of theft of services and grand larceny on cases that Officer Mat Nadeau had pending against him. The court clerk was contacted and bail was set at \$750.00 cash. He was transported to the county jail.
- September 9, 2016@ 15:59 hours, Officer John Hamlin was dispatched to the Triple Buckets for a report of a group of college age kids intoxicated. When Officer Hamlin arrived he spoke with the group leaving the area as well as a group just coming, however none appeared to be intoxicated.
- September 11, 2016@ 13:00 hours, Cpl. William Bullock was requested to respond to the Potholes swimming area for a report of a swimmer stuck in the hole. When he arrived it was determined that the swimmer was freed without harm.
- September 12, 2016@ 15:13 hours, Officer John Hamlin assisted the Vermont State Police with a large fuel spill which started on Skunk Hollow Road in Jericho and ended near the firehouse on Route 15 in Underhill. John assisted with photographs and statements while Skunk Hollow Road had to be closed down for 3 hours for cleanup.

- September 12, 2016@ 18:13 hours, Cpl. Brett Lindemuth and Officer Mat Nadeau assisted the Vermont State Police with interviews in the Huntington area related to the recent stabbing that took place in Huntington. This investigation is ongoing at this time.
