### **TOTAL INCIDENTS REPORTED: 55**

- August 15, 2017@ 16:35 hours, Sgt. Mat Nadeau took a suspicious complaint from a town
  resident. She had received a call indicating that it was the I.R.S. calling and if she did not pay a
  debit immediately the police would be called to arrest her. This is a scam call that has been
  going around for a couple of years now and is starting again. Do not reply to these calls just
  hang-up.
- August 16, 2017 Officer Hamlin had spent several days in court on a case he handled last fall in
  which a women was the victim of an aggravated domestic assault to include running her arm
  over with his car. This was not his first offense and the jury came back today with a guilty
  verdict. Hopefully with his past felony convictions he will be spending considerable time behind
  bars.
- August 17, 2017@ 18:39 hours, Sgt. Mat Nadeau conducted a traffic stop on Cochran Road. A
  computer check revealed that the operator was currently criminally suspended in Vermont and
  was on court conditions from a case last month where I charged him with leaving the scene of
  an accident and criminal suspension. It was also determined that the inspection sticker on the
  car was a counterfeit and he was in possession of someone else suboxone. He was processed
  and cited into Superior Court.
- August 18, 2017@ 18:22 hours, Cpl. John Hamlin responded to a three vehicle accident with reported injury by 920 West Main Street. Richmond Rescue along with the Richmond Fire Department also responded to the scene. Rescue ended up transporting one female to the emergency room with non life threatening injuries. The investigation revealed that this collision occurred as a result of one vehicle going over the center line when she apparently fell asleep at the wheel, she was issued a traffic ticket for the violation and Blackfork Towing/Recovery ended up removing all three vehicles as the collision occurred at the end of his driveway.
- August 19, 2017@ 14:03 hours, Cpl. William Bullock assisted in locating a wanted subject from corrections who had cut off his GPS ankle bracelet and a warrant was issued. He was located on foot on Kenyon Road and was taken into custody without incident by members from Winooski and Burlington police and returned to jail.
- August 20, 2017@ 12:04 hours, Cpl. William Bullock was monitoring traffic on Gov. Peck Road
  when he heard some dogs going at it and a women screaming coming from the trailer park.
  When he arrived at the scene it was determined that the dogs had attacked a cat and in the

- process of trying to separate them one women got cut up and was bleeding enough that Richmond rescue was dispatched. Because of a lack of vaccinations records both the Town Health Officer and Town Constable were made aware and will be following up on the case.
- August 20, 2017@ 15:47 hours, Cpl. Brett Lindemuth responded to the trailer park for an assault
  complaint. Seems one family was having a birthday party for their child when a neighbor started
  arguing with them over parking and ended up spitting in the face of the victim. The suspect was
  cited into court on a simple assault charge.
- August 21, 2017@ 19:26 hours, Cpl. Brett Lindemuth was dispatched to East Main Street for a
  physical fight between two men near McKee's. Turns out the two were arguing over a woman
  who was not present and ended up in a physical fight that required one to seek treatment at the
  emergency room. Both adult males were cited into court on a simple assault charge, mutual
  affray.
- August 22, 2017@ 00:30 hours, Cpl. Brett Lindemuth assisted the State Police and Richmond Rescue with a report of two overdose victims (heroin) in Huntington. When Cpl. Lindemuth arrived a male pulled a handgun on him forcing him to take cover until VSP arrived and the situation was defused and both were examined by rescue but both refused transport.
- August 23, 2017@ 07:58 hours, Cpl. Rick Greenough assisted VSP with a motorcycle pursuit on the Interstate in which the motorcycle was travelling well over 100 mph. The operator finally stopped and he was taken into custody.
- August 25, 2017@ 14:24 hours, I was sitting in the parking lot of the Lucky Spot Store when a motorcycle pasted my location travelling between 85-90 miles per hour. After 3 mile chase I was able to stop the 28 year old male who was currently under civil suspension. I issued him multiple traffic violations and a tow truck was requested to remove the motorcycle.
- August 27, 2017@ 14:31 hours, Cpl. Rick Greenough assisted the Vermont State Police near exit
   11 with a DUI stop. This was the operator's third offense (felony) and he was taken into custody
   by VSP while Cpl. Greenough stood by until the tow truck arrived to remove the vehicle.
