Thank you for considering my application to serve on Richmond's Conservation Commission. I've lived or worked in the Richmond/Huntington area for the last eight years and have a deep appreciation for the rivers, fields and forests in this part of the Green Mountains. I've worked in the field of conservation for twenty years and would bring to this position a passion for our local ecology and a collaborative spirit.

For the past five years, I've worked at the Vermont Youth Conservation Corps. In my current role, as the Chief Program Officer, I work closely with both our Conservation and Farm programs to create a dynamic experience that connects young people with the natural world. Prior to this, I was the Education Manager at the Green Mountain Audubon Center in Huntington, leading science education programs on topics ranging from Forest Management for Birds to Pond Ecology. And before that, I taught a variety of ecology classes at CCV including Field Biology, Wetland Ecology, and Environmental Science. The common thread that runs through these career paths is my desire to not just implement conservation projects but to engage a wide variety of people in those projects. Through the process of literally getting our hands dirty—pulling invasives, planting riparian trees, building erosion control structures— we create connections that have a lasting impact.

Prior to Vermont, I completed a PhD in Physical Geography from the University of California, Berkeley and spent many years researching the effects of climate change on tropical ecosystems. I also worked in a variety of secondary and post-secondary schools and have a passion for facilitating experiences in the outdoors. My career path has always meandered between education and science, and I'm fortunate to have found a position at VYCC where I can wear both my educator hat and ecologist hat.

My interest in the natural world is always changing but birds and amphibians continually make it to the top of my list. The years I spent at Audubon helped me really see (and hear!) the bird life that constantly surrounds us. I also became fascinated by amphibians after my first night spent shuttling salamanders across Sherman Hollow Rd. Then again, I would love to be better at identifying dragon and damselflies. There are so many things to get excited about!
