MEMO RE: Police Cruiser PO

December 16, 2021

Mr. Arneson,

This memo is intended to provide clarity about the purchase order I submitted. In the FY 22 budget for the Police Department, I have funds approved for the purchase of a Dodge Durango police cruiser. I have been in contact with Goss Dodge for month waiting for Dodge to take orders on the police package Durango.

On November 21, 2021 I was notified that Dodge was now accepting orders for the 2022 Durango Pursuit police vehicles. I communicated back and forth with Sales Rep. John Munier on things like vehicle color, engine size, desired options etc. Fairly abruptly, on December 8, 2021, I received and email from John stating that they had just gotten word from corporate that ALL Durango orders had to be submitted by close of business on December 8, 2021. From the day that the announcement was made that orders would be accepted to the submission deadline was 12 calendar days.

My suspicion is that the short turn around had to do with supply chain issues. I further suspect that these issues haven't markedly improved in the last week. I intend to follow a normal procurement process if possible. If the board approves the PO in an amount not to exceed \$40,000 with the vendor TBD, it would give me some latitude and the ability to make a commitment on a purchase should I find myself in another scenario like the one I was in with Dodge.
