- On 12/07/18 Cpl Lindemuth responded to a two car motor vehicle crash on Route 117, at the intersection with Governor Peck. The operator coming off Gov. Peck failed to yield the right of way to the vehicle traveling west on Rt. 117. There were no injuries, but significant vehicle damage.

- On 12/07/18 Cpl Lindemuth met with a resident on Lawrence Road regarding an ongoing dispute. The complainant was feeling stalked and wanted to discuss his legal options.
- On 12/08/18 Cpl Bullock received a call regarding a welfare check. The caller was concerned about a resident on Governor Peck and wanted to ensure he was safe. The subject of concern was located a short while later at his place of employment by the South Burlington Police, who confirmed that he was fine.
- On 12/09/18 Cpl Bullock responded to a theft complaint on Snipe Ireland Road. A Resident reported that a trailer loaded with wood was stolen the previous night. A bulletin was issued for the stolen trailer, investigation continues.
- On 12/12/18 Cpl Bullock and I responded to a citizen assist on Hidden Pines Ext. A resident had locked themselves out of their home and were looking for assistance getting in. A neighbor had already checked all doors and first and second floor windows, which were all secured. We assisted the homeowner in contacting a locksmith to help gain entry.
- On 12/12/18 Cpl Bullock responded to a report of a dog bite at North Star Guns on East Main Street. Cpl Bullock learned that a dog had nipped a hand of a customer, resulting in the customer being seen in the emergency department.
- On 12/12/18 Cpl Bullock responded to a residential alarm on Grandview Drive. A checked determined that the residence was secured, alarm was false.
- On 12/14/18 Cpl Bullock was dispatched to a MV Complaint on Snipe Ireland Road, callers reported a car in the ditch. Upon arrival he found the vehicle was not occupied. The vehicle was removed and he later followed up with the owner.
- On 12/14/18 Cpl Bullock responded to the Sterling House on Farr Road for a 911 hang up. His investigation determined that it was a false alarm, a resident was not familiar with a new phone and had dialed 911 by accident.
- On 12/14/18 Cpl Lindemuth was dispatched to a report of an erratic operator. He located the vehicle and followed for a short period of time. The operator appeared to be operating safely.
- On 12/14/18 Cpl Lindemuth responded to the Sadler Meadow Neighborhood for a report of possible gunshots. He patrolled the area, did not any further shots and was not able to located the source.
- On 12/15/18 Cpl Bullock responded to an ongoing custody dispute on East Main Street. Cpl Bullock was ultimately able to mediate the dispute.
- On 12/16/18 Cpl Bullock responded to a business alarm on Railroad Street. A check of the business was performed, all appeared secure.
- On 12/17/18 Officer Pecor assisted the Winooski Police by making contact with a Richmond resident regarding a minor collision that had occurred earlier in the day in Winooski.
- On 12/17/18 Officer Pecor responded to a single vehicle that had slid off the road on Kenyon Road. She stood by until the vehicle was pulled back on.
- On 12/18/18 I responded to a single vehicle roll over on Browns Trace Road in Jericho. The only state trooper on duty at the time was already tied up with another crash.

- On 12/18/18 I was dispatched to a residence on West Main Street for a report of a larceny from a residence. The complainant advised that his friend had been staying with him for a few weeks. He let the friend borrow his car and they were late returning it. When he arrived home he discovered that a large number of electronic items had been stolen from the residence. We reviewed his security system and discovered that the friend had returned to the residence with another individual and taken the electronics, all of which was captured on video. I located the suspect, and after being confronted with the video, confessed to taking the items. They were cited and released for felony grand larceny.
- On 12/19/18 I responded to a minor 2 car motor vehicle collision at the intersection of Governor Peck and Vt. Route 117. Once again a vehicle coming off Governor Peck failed to yield right of way to the vehicle on Rt 117. No injuries, minor damage.
- On 12/19/18 Officer Pecor assisted the Barre City PD by flash citing a resident for Aggravated Sexual Assault for them without incident.
- On 12/23/18 Officer Pecor assisted the Williston Police, who had a subject in custody who was posing an officer safety risk.
- On 12/24/18 Officer Pecor responded to a report of a crash called in by AAA. The location of the spot where the vehicle had gone off the road, but was now gone.
- On 12/24/18 Officer Pecor responded to Williston to assist the Williston PD with a domestic involving a highly intoxicated female.
- On 12/26/18 Cpl Lindemuth responded to a single vehicle collision on Cemetery Road. There were no injuries, the operator was ultimately issued a ticket for defective equipment, which was determined to be the cause of the crash.
- On 12/27/18 Cpl Bullock responded to Christmas Hill for a report of ATV's driving up and down the road. Cpl Bullock made contact with the juvenile operators and educated them on the laws involved in operating ATV's.
- On 12/29/18 Cpl Bullock responded to 2 alarms at a business located on East Main Street. Both times the business was checked and found to be secure.
- On 12/29/18 Cpl Bullock responded to a 911 hang up on Hilltop Circle. Investigation determined a 3 year old had been playing with a phone, no emergency.
- On 12/31/18 Cpl Lindemuth responded to a report of a theft from a secured motor vehicle. A window was smashed out and lottery tickets were taken.
- On 12/31/18 Cpl Lindemuth responded to a report of a possible suicide in a vehicle parked in a pull off on Johnnie Brook Road. Cpl Lindemuth assisted members of the Vermont State Police Bureau of Criminal Investigations with the suicide investigation.
- On 12/31/18 Officer Pecor responded to a residence for a report of a man suffering a panic attack. She spoke with the individual and ultimately convinced them to be transported by rescue to the emergency department for an evaluation.
- On 01/01/19 Cpl Bullock responded to Kenyon Road for a report of a vehicle stuck, that had been there for a while. The road was very slick, Cpl Bullock stood by until the vehicle had been pulled back on the roadway.

- On 01/01/19 Cpl Bullock received a complaint from a resident on West Main Street regarding damage to his mailbox. The mailbox had been knocked down by a vehicle that had left the roadway, struck the mailbox and left the scene.
- On 01/01/19 Cpl Lindemuth responded to a fireworks complaint on Summer Street. He was not able to locate the source of the fireworks, no further complaints were received.
- On 01/02/19 Officer Pecor Initiated a motor vehicle stop for a vehicle running a red light. The operator had been drinking and was screened for DUI. He provided a breath sample of .108%BAC and was processed and cited for DUI.
- On 01/03/19 Cpl Bullock responded to a business on East Main Street for a report of a possible assault. After investigation it was determined that the two males involved had a history of not getting along. The case is being forwarded to the State's Attorney's office for review of possible criminal charges.
- On 01/06/19 I responded to an alarm at the Richmond Elementary School. I located an art teacher in the building who had set the alarm off by mistake.
- On 01/07/19 Officer Pecor responded to a report of a single vehicle slide off on Sherman Hollow Road in Huntington at the request of the state police because they did not have a trooper available. She stood by until the vehicle was returned to the roadway.
