Dear Mr. Wardwell.

I am applying for the Andrews Community Forest Committee because I am very interested in the wonderful recreation, conservation, and educational opportunities this unique parcel offers Richmond residents. Our family spent a good deal of time at ACF during the early days of the pandemic - walking, observing nature, and getting to know the features of the forest. I have also become familiar with the history of this land and its aquisition by the town. I have studied the Master Plan created to guide the mangement of the forest, and have attended a number of the ACFC meetings.

My background is primarily in social work, and I worked for many years at the Howard Center in Burlington in both adult mental health and developmental services. I also recently finished three years as a Guardian ad Litem, which is a volunteer position in Chittenden Family Court advocating at court hearings for children who are negleted or abused.

Early in my career, I worked for a partnership amongst The Nature Conservancy, the Adirondack Mountain Club, and the NY State Dept of Environmental Conservation. My responsibilites included searching for, and cataloging rare artic alpine plants as well as educating the hiking public about the fragile nature of these plants. I did field training with Dr. Ed Ketchlidge from SUNY.

In Richmond, I volunteered for 5 years teaching hands-on nature classes at Richmond Elementary School with curriculum deleveloped by VT Institute of Science. I have also

volunteered for several trail work days sponsored by the Trails Committee, as well as vounteer trail work for the Adirondack Mountain Club.

I am an avid hiker, and finished the Long Trail end to end last fall, and am an Adirondack 46er.

I look forward to hearing from you about the ACFC process.
