Subject: Submit Comments on new Wetlands Rules Re: [AVCC] Executive Order 06-25

Hello AVCC members,

As explained previously in the emails below, the Vermont Agency of Natural Resources (ANR) intends to amend the state Wetlands Rules to remove some protections for wetlands, as ordered by the Governor. The rules would allow housing to be built in wetlands and their buffers in certain areas. The ANR is now in the process of taking public comments on the proposed rules before the rules can be finalized. For the reasons stated in my previous email (below), please consider submitting comments in opposition to these changes to the Wetlands Rules.

Comments on the proposed changes to the rules can be submitted by 1) email; 2) in person (or virtually) at the scheduled public hearing. As provided by the Wetlands Program staff, the information on the proposed rules and submitting comments is below:

Good afternoon AVCC members,

In response to this morning's email from the Vermont state Wetlands Program managers regarding new state wetland rules:

I urge members of the AVCC and Vermont Conservation Commissions to OPPOSE changes to the Vermont wetland rules as described in the Governor's Executive Order (referenced in the state's email).

The proposed changes to the state wetlands rules would, in certain areas, reduce the buffer zones around Class II wetlands: decreasing the buffer zone requirement from the current 50 feet, down to 25 feet. This generally means that development in those areas would no longer be prohibited within 50 feet of a Class II wetland. The protected area would be only 25 feet.

In addition, the Executive Order means that wetlands that have not yet been mapped on the state wetlands maps will no longer be protected. Under the current rules, any wetlands that meet the criteria for a Class I or Class II wetland are considered protected—mapped or not. [See https://dec.vermont.gov/watershed/wetlands/wetland-maps] The new rules will mean that many wetlands could now lose protections from development. A significant number of wetlands have already been lost to development. We cannot afford to lose more.

Wetlands are extremely valuable natural resources that provide a number of important functions: flood control, ground water recharge and discharge, water quality improvement, shoreline stabilization, fish and wildlife habitat, recreational and educational opportunities, and aesthetic values. Development closer to wetlands can have negative impacts on the wetlands and its functions—such as increased runoff, sedimentation, introduction of pollutants, diversion of water supply, introduction of invasive and exotic species, and reduced populations of wetland-dependent species. The closer to the wetland that development occurs, the greater the impacts.

The state's own website explains the importance of wetlands and adequate wetland buffer zones.

In order to increase housing development, the Scott administration has chosen to reduce environmental protections for one of our most valuable resources: wetlands. I understand the need to improve access to housing for Vermonters, but this particular path to achieve that goal seems ill-conceived and extremely short-sighted. The function that wetlands provide in helping to prevent flood impacts seems justification alone to protect them for the increased safety of Vermonters—especially since we are seeing more flooding due to climate change. Putting housing in what are essentially wet areas to begin with (wetlands), and by doing so, increasing stormwater runoff due to new impervious surfaces (housing units and associated driveways, etc.), seems a risky and not very smart proposal.

Please consider telling the state wetlands managers (through the contact information in their email) that you oppose the plan to lessen protections for Vermont's wetlands. There will soon be a state "rulemaking" process to finalize the proposed changes to the wetlands rules. Ask that any comments you send to the wetlands managers be included as comments in opposition to those final changes to the wetlands rules.

Laura Lapierre, Wetlands Program Manager, has asked that I share this information with you. Thanks for all that you do in your communities.

Have you heard about Executive Order 06-25, "Promoting Housing Construction and Rehabilitation"? This Order includes steps to be taken by the Department of Environmental Conservation with the intent of supporting specific types of housing projects. We are receiving questions about this Order and want to make you aware of what this Order might mean for your town regarding wetland regulations.

<u>Initial guidance</u> is now available. You can visit the Department of Environmental Conservation's <u>Executive Order website</u> for updates.

Here are some key points:

- Current wetland rules still apply. For now, the 2023 Vermont Wetland Rules remain
 in effect. Wetlands that aren't shown on maps but meet certain criteria or are next to
 mapped wetlands are still protected, including their 50-foot buffer zones. Most of the
 changes mentioned in Section 3.1 of the EO are not in effect yet.
- Rulemaking starts this October. The Agency will begin the formal process to update
 the Vermont Wetland Rules in October. The proposed rule amendment will allow
 certain residential housing projects to proceed without a wetland permit. This process
 will include an opportunity for public comments.
- Changes apply only to certain areas. The wetland regulation changes will apply
 only in designated residential growth areas, which make up no more than 6% of the
 land in Vermont. You can use the <u>online map viewer</u> to see what areas of your town
 are currently included.
- Only residential housing projects are eligible. If the proposed changes are approved, they will apply only to residential housing projects in the designated areas.
