"Is this an order?"

REQUEST

ICE detainer, admin warrant

YOU CAN REFUSE

"I do not consent."

ORDER

Judicial warrant with judge signature

YOU MUST COMPLY

Do not physically resist

YOUR CONSTITUTIONAL RIGHTS

1ST AMENDMENT

Right to record in public
Right to observe (10+ ft away)
Right to protest peacefully

4TH AMENDMENT

Right to remain silent
Right to refuse searches
Right to ask: "Am I free to go?"

WHAT TO SAY

"I do not consent."

"I wish to remain silent."

"I want a lawyer."
