Late proposals will not be accepted and will be automatically disqualified from further consideration. All proposals and any accompanying documentation become the property of the TOWN and will not be returned.

Proposals will be opened and read aloud at 2:00pm on May 7th, 2025 in the Town Center Meeting Room 3rd Floor and via Zoom.

Payment must be received in full 3 business days after the bid is awarded. Payment in full means any checks presented for payment must clear. If payment is not received within 3 business days, the award will go to another bidder in the process, with the same 3 business day payment requirement. Successful bidder must remove Fry Wagon from Highway Garage no later than 2 weeks after the bid opening. If there are no bidders, the Town reserves the right to go back out for bids.
