Thank you for those Duncan. That helps me understand the proposed project. It would present a bit more liability for the Town because anything like this also needs to be maintained for safety. If this is a project that the Town isn't looking to be part of, or doesn't want the additional maintenance requirements, the Town would need to create a contractual agreement with Umiak that clearly states that the steps are their responsibility. You would want to define what parties are responsible for both installation and ongoing maintenance but also get a COI from Umiak with the Town as additional insured for the Town's insurable interest as landowner. If no contract is in place, the liability would fall to the Town. A contract doesn't necessarily protect the Town 100% from suit, but it does provide an initial layer of protection that Umiak should be primary for any claims.

Hi Duncan,

Can you please provide a little more information on Overrocker Park and where the ladder would be going? What type of ladder are you considering? What is Umiak's interest in the project? If it will be on Town property, then the Town ultimately assumes liability for the ladder and any foot traffic using it unless there is a contract that states otherwise. Who would be maintaining the ladder for ongoing safety?

We may also reach out to our Loss Control Department if there are some additional Risk Management Guidance tips they can provide, but first want to get a better sense of what the project will entail.
