Hello Richmond Select Board,

I am writing to express my interest in being reappointed to the Richmond Conservation Commission. In October of 2014 I was appointed for about six months to fill out the end of a vacated seat that expired in April of 2015. I was then appointed for 2 four-year terms, which I have now served. I wish to continue to remain on the Commission. I feel I have been a committed RCC member and have brought value to RCC through my service and support of our Chair and our committee work.

In 2017, on behalf of RCC, I served on the Richmond Town Forest Steering committee with Guy Roberts as one of the two RCC members of the large and diverse committee. I was chosen as one of the five people who made the final choices of the members of the Richmond Community Forest Management Committee. I went to all the RCC meetings that I could—only rarely missing them, and I play an active role in the committee conversations and efforts. I do my best to contribute to the RCC and support our excellent Chair, Judy Rosovsky and the other committee members by: being an active voice in our RCC meetings, reading the meeting minutes carefully and offering editing comments, editing other documents we write, volunteering for tasks like chairing a committee meeting in Judy's rare absence, posting RCC-related announcements on FPF and signs to deter over-harvest of fiddlehead ferns on town land, attending a state-wide conference of Vermont conservation commissions, serving as RCC's coordinator of Green Up Day alongside Linda Parent these past two years, and working on the 3-person subcommittee who planned the very successful speakers panel and discussion event in March 2023 called "Balancing Conservation and Trail-Based Recreation."

I very often am out hiking and appreciating the natural areas and trails in Richmond, and I am very interested in how decisions are made with the Conservation Reserve Fund, and in helping to maintain the natural and historical resources and values of Richmond.

I have enjoyed these eight and a half years on the board and wish to continue to serve the Commission and the town of Richmond. I consider it a privilege and an honor to serve the town on the Conservation Commission. I will do all I can to continue to serve it well and represent the town as best I can during a third full term. It feels good to take part in the community in this way and to do what I can for the benefit of all Richmond's citizens, and the land, water and wildlife. I am very interested in helping to maintain Richmond's character and increasing public land availability for all.
