Dear Municipal Official,

We are seeking input on our DRAFT 2<sup>nd</sup> Amendment for the Vermont Recovery Housing Program Action Plan. In 2020 the State of Vermont – Agency of Commerce and Community Development (ACCD) – Department of Housing and Community Development (DHCD) started receiving funding through HUD's Support Act funding, Recovery Housing Program due to Vermont's opioid death rate. This funding is a five-year HUD pilot program to help individuals in recovery from substance used disorders (SUD) become safely housed. This funding is to support the creation of transitional housing for Vermonters suffering from SUD and safely house them for up to 2 years. ACCD has worked with various stakeholders and the Agency of Human Services (AHS) on its action plan which outlines the use of the funds and allows Vermont to access the funds. We now need to amend the plan to include the states FY23's \$991,106 allocation.
