Noted exceptions to contract language below:

This agreement with Joshua Moore - Williston Police Dept. is a guardianship with the understanding that the Boonefield Labrador black male will accompany Joshua and/or Matt Cohen on duty with the Williston Police Dept., in some form of therapy / service capacity. Joshua and Matt agree to train, care and feed "Duke" as advised by Boonefield Labradors. Joshua and Matt will consult with Boonefield prior to neutering to allow Duke to be evaluated as a potential breeding prospect for exclusive use by Boonefield Labradors.

A pet PUPPY is defined here to be a Labrador Retriever puppy which is in good health at the time of sale, and embodies the characteristics of the Labrador Retriever breed. This PUPPY is purebred and is registerable (registered) with the American Kennel Club.

The parents of this PUPPY have had x-rays to establish that they are free of hip and elbow dysplasia.

This PUPPY is registered with a limited registration, which will prohibit breeding and registering offspring. (The BUYER agrees this PUPPY is to be spayed or neutered at the appropriate age, and veterinarian confirmation of this procedure must be supplied to the BREEDER.)

The BREEDER guarantees the above described dog to be healthy at the time of the sale.

The BREEDER does not assume any liability for any injury to said puppy after delivery.

The BUYER agrees to have this puppy examined by a veterinarian within 3 days of delivery.

If the puppy is found to be other than healthy by the BUYER'S veterinarian, it shall be returned to the BREEDER immediately, and the purchase price will be refunded. Deadline for this refund is Saturday, May 16, 2020.

All appropriate shots for the PUPPY'S age have been given, and a record of this vaccination history is supplied.

The BUYER agrees to maintain the puppy's health in good condition, and to provide yearly examinations, vaccinations, heartworm test, and any other usual procedures necessary to assure good health.

The BREEDER has done everything possible to produce healthy sound puppies both by breeding only dogs (parents) that are certified free of hip and elbow dysplasia, as well as, PRA, EIC and CNM and by raising the puppies in the best way possible in regards to diet, exercise, socialization and veterinary care.

There are many factors that can influence growth and development, such as diet, exercise, weight gain, etc. The BUYER assumes the responsibility to carry on with the appropriate vaccinations, exercise and feeding schedule, as supplied by the BREEDER. *MOST PARTICULARLY, the BUYER agrees to keep the puppy sufficiently fed throughout its normal growth period and to not force exercise.*

The BREEDER neither makes nor implies any warranties or guarantees, express or implied, other than those written in the agreement including, without limitation, the warranties of merchantability and fitness. This document constitutes the entire agreement between the Breeder and Buyer with respect to this sale.
