- Send out selection of heads for UL testing due to being over 20 years old
- Change corroded head outside of the storage room on the 1st floor
- · Lengthen the pipe in the elevator pit so the head meets code requirements
- Replace corroded head in bathroom on 2nd floor
- Replace corroded head in 1st floor stairway landing
